### NORTHERN IRELAND COURT SERVICE

#### JUDGMENTS ENFORCEMENT (NORTHERN IRELAND) ORDER 1981

This Order (SI 1981/226 (N.I.6), price £4.50) was made on 18th February 1981 and consolidates most of the provisions of the Judgments (Enforcement) Act (Northern Ireland) 1969 and related enactments. It also repeals certain statutory provisions which were rendered obsolete by the Act of 1969 and other pre-1969 provisions that are unnecessary. The Order, with the exception of Part VII, comes into operation on 19th March 1981.

#### JUDGMENTS ENFORCEMENT (NORTHERN IRELAND) CONSEQUENTIAL AMENDMENTS ORDER 1981

This Order (SI 1981/234, price 70p) made on 18th February 1981 makes amendments to the Towns Improvement Clauses Act 1847, the Purchase of Land (Ireland) Act 1891, the Payments for Debt (Emergency Provisions) Act (Northern Ireland) 1971, the Social Security (Northern Ireland) Act 1975 and the Child Benefit (Northern Ireland) Order 1975 which are consequential on the Judgments (Enforcement) Act (Northern Ireland) 1969 (c. 30), the Judgments Enforcement and Debts Recovery (Northern Ireland) Order 1979 (SI 1979/292 (N.I.3)) and the Judgments Enforcement (Northern Ireland) Order (SI 1981/226 (N.I.6)). The Order comes into operation on 19th March 1981.

### SOCIAL SECURITY ADVISORY COMMITTEE

#### NOTICE OF SUBMISSION OF DRAFT REGULATIONS ENTITLED THE SOCIAL SECURITY (MATERNITY GRANT) REGULATIONS 1981

The Social Security Advisory Committee gives notice that it has been asked by the Secretary of State for Social Services under Section 10 of the Social Security Act 1980 to consider and report on the draft of regulations entitled The Social Security (Maternity Grant) Regulations 1981.

These Regulations will apply to Great Britain only. Corresponding provision for Northern Ireland will be made in regulations made by the Department of Health and Social Services for Northern Ireland under the Social Security (Northern Ireland) Act 1975 (1975 C.15), as amended by Article 6 of the Social Security (Northern Ireland) Order 1980 SI 1980 No 87 (NI 8). The Northern Ireland Regulations will not require prior submission to the Social Security Advisory Committee by virtue of paragraph 21 of Schedule 3 to the Social Security Act 1980 (1980 C.30).

A short explanatory note provided by the Department of Health and Social Security on these regulations is appended to this notice. The Committee will take into account any comments or objections, made by or on behalf of people or organizations who would be affected by the corresponding regulations for Northern Ireland received by them not later than 13th April 1981. #### *Explanatory Note*

These draft regulations make provision consequent upon the replacement of contributory maternity grant by non-contributory maternity grant by virtue of Section 5 of the Social Security Act 1980 which amended the Social Security Act 1975, in respect of confinements on or after 4th July 1982.

Draft regulation 2 amends the Social Security (Maternity Benefit) Regulations 1975 and prescribes the periods for which a woman must be present in Great Britain to establish entitlement to non-contributory maternity grant. It also provides that certain periods during which a woman is temporarily absent from Great Britain may be included as part or parts of the total period for which presence in Great Britain is required.

Draft regulation 3 amends the Social Security (Persons Abroad) Regulations 1975 and specifies that a woman shall not be disentitled to Maternity Grant by reason only that she was confined outside Great Britain if she can satisfy one of the conditions specified. It also provides that in such cases a woman shall not be disqualified from receiving payment of the benefit while absent from Great Britain.

(AMENDMENT) REGULATIONS (NORTHERN

## CENTRAL SECRETARIAT

The following Orders in Council were made at a Privy Council Meeting on 18th February 1981.

### WEIGHTS AND MEASURES (NI) ORDER 1981

This Order consolidates the Weights and Measures Act (NI) 1967 and related enactments.

### FISHERIES (AMENDMENT) (NI) ORDER 1981.

This Order amends the Foyle Fisheries Act (NI) 1952, the Fisheries Act (NI) 1966, the Diseases of Fish Act (NI) 1967 and the Fish Industry Act (NI) 1972.

It deals with regulations regarding the keeping of records, punishment for offences, regulation of sea fishing, provisions for shell-fish fishery licences, and other enactments.

### NORTHERN IRELAND (VARIATION OF LIMITS OF CANDIDATES EXPENSES) ORDER 1981

This Order increases the maximum amount of candidates' election expenses at local elections in Northern Ireland. The amounts were last increased by the Representation of the Peoples Act 1977, and the increases made are such as are justified by the change in the value of money since then.

### LEGAL AID, ADVICE AND ASSISTANCE (NI) ORDER 1981

This Order consolidates the Legal Aid and Advice Act (NI) 1965 and the provisions amending it.

### THE CROWN PROCEEDINGS (NI) ORDER 1981

This Order, which supersedes the Northern Ireland (Crown Proceedings) Order 1949 and the Northern Ireland (Crown Proceedings) (Amendment) Order 1971, extends the Crown Proceedings Act 1947 to Northern Ireland with such additions, exceptions and modifications as are needed to make the Act effective in Northern Ireland both in relation to the Crown in right of the Government of the United Kingdom and in relation to the Crown in right of the Government of Northern Ireland.

### SOCIAL SECURITY (CONTRIBUTIONS) (NI) ORDER 1981

This Order is made only for purposes corresponding to those of the Social Security (Contributions) Act 1981.

It increases the national insurance contribution rates of employed and self-employed earners and voluntary contributors, increases the lower and upper earnings limits for the payment of contributions by employed earners and their employers, the small earnings exception below which self-employed earners may be excepted from liability to pay a flat-rate contribution, and the upper and lower limits of profits or gains between which earnings-related contributions are payable by self-employed earners.

It reduces the percentage rate of the Consolidated Fund supplement to national insurance contributions and empowers the Department of Health and Social Services to amend by order the percentage rate of the supplement in relation to future tax years by up to two percentage points.

It increases the percentage rates of the health service allocation deducted from primary Class 1 contributions and from Class 2, 3 and 4 contributions and paid towards the cost of the health service, and empowers the Department of Health and Social Services to amend by order the

percentage rates of the allocation from all classes of contributions in respect of future tax years within specified limits.

**PATIENTS' AFFAIRS (FINANCIAL LIMITS OF JURISDICTION) (NI) ORDER 1981**

This Order increases the financial limits in the jurisdiction

of the High Court of Justice in Northern Ireland to make, without an inquiry under a commission of lunacy, an order (1) protecting the property or the income of a person who is incapable, by reason of mental disorder, of managing and administering his property and affairs, or (2) applying it for his benefit.
