## DEPARTMENT OF AGRICULTURE

AGRICULTURE (MISCELLANEOUS PROVISIONS) (NORTHERN IRELAND) ORDER 1975

Notice is hereby given that the Department of Agriculture for Northern Ireland, in exercise of the powers conferred on it by paragraphs (1), (2) and (3) of Article 2 of the Agriculture (Miscellaneous Provisions) (Northern Ireland) Order 1975 and of every other power enabling it in that behalf made on 6th March, 1981, the Pigs (Carcase Classification Scheme) (Amendment) Order (Northern Ireland) 1981, S.R. No. 68, which will come into operation on 6th April, 1981.

## DEPARTMENT OF COMMERCE

Notice is hereby given that the Department of Commerce, with the approval of the Department of Finance, has made a statutory rule entitled Industrial Assurance (Fees) Regulations (Northern Ireland) 1981 (SR 1981 No 57) which comes into operation on 1st April 1981.

These regulations provide for a substantial increase in the fees payable in connection with the exercise by the Industrial Assurance Commissioner of his functions under the Industrial Assurance (Northern Ireland) Order 1979 and for the inspection and the furnishing of copies or extracts of documents in his custody. The fees payable for reference of a dispute to the Commissioner and in respect of an application to him under Article 36(3) of the said Order remain unchanged.

These Regulations supersede the Industrial Assurance (Fees) Regulations (Northern Ireland) 1980.

# DEPARTMENT OF HEALTH AND SOCIAL SERVICES

by Sections 30 and 31 of the Misuse of Drugs Act, 1971, as adapted by Section 38 of the Act and now vested in it by the Departments (Transfer of Functions) Order (Northern Ireland) 1973, S.R. & O. (N.I.) 1973, No. 504; has made regulations entitled:—Misuse of Drugs (Licence Fees) (Amendment) Regulations (Northern Ireland) 1981 (S.R. 1981, No. 55).

These regulations, which become effective from 1st April, 1981, prescribe a new scale of fees for licences to produce, supply and be in possession of controlled drugs.

Republic of Ireland: Official Certificate
