## NORTHERN IRELAND COURT SERVICE

Notice is hereby given that the Lord Chancellor, in pursuance of Article 141(1) of the Judgments Enforcement (Northern Ireland) Order 1981, has made a Statutory Rule entitled the Judgment Enforcement Rules (Northern Ireland) 1981 (SR No 147).

These Rules which come into operation on 15th June 1981 revoke the Judgment Enforcement Rules 1979 and the Judgment Enforcement (Amendment) Rules 1981. They prescribe the procedure to be followed by the Enforcement of Judgments Office and the Office of the Master for the Enforcement of Judgments.

The Rules contain a number of new provisions:

Rule 5(f) to (i) prescribes further limitations on enforcement;

Rule 13 increases from £500 to £1,000 the amount that the outstanding balance of all monies due and payable under the judgment must exceed before the creditor may apply for a custody warrant and report under Article 23(1) of the Order:

Rule 33 makes provision for the remuneration of valuers and brokers;

Rule 54(5) makes provision for the issue of an attachment of earnings order which has been suspended;

Rule 80 makes provision for returns and accounts to creditors;

Rule 100 makes provision for notice to be given of an application for an order revoking an administration order;

Rule 101 makes provision for an order revoking an administration order and referring the administration of the debtor's estate to the High Court to have the debtor adjudicated bankrupt; and

Rule 103(6), (7) and (8) relate to the jurisdiction to stay enforcement.
