NORTHERN IRELAND COURT SERVICE

Notice is hereby given that the Lord Chancellor, in pursuance of section 116(1) and (4) of the Judicature (Northern Ireland) Act 1978 and sections 2 and 3 of the Public Offices Fees Act 1879, has made a Statutory Rule entitled the Matrimonial Causes Fees Order (Northern Ireland) 1981.

This Order, which comes into operation on 1st September 1981, fixes the fees to be taken in all matrimonial proceedings, whether in the High Court or a divorce county court.

Copies of the Order — Statutory Rules of Northern Ireland 1981 No. 195 — may be obtained from the Government Bookshop, 80 Chichester Street, Belfast BT1 4JY.

Notice is hereby given that the Lord Chancellor, in pursuance of Article 54 of the Matrimonial Causes (Northern Ireland) Order 1978, has made a Statutory Rule entitled the Matrimonial Causes (Costs) Rules (Northern Ireland) 1981.

These Rules, which come into operation on 1st September 1981, make provision for the costs of matrimonial proceedings in the High Court and in a divorce county court on the coming into operation of the Divorce County Courts Order (Northern Ireland) on 1st September 1981.

Rule 3 provides that the costs of any matrimonial proceedings in a divorce county court may be taxed by the taxing master.

Rule 4 prescribes the time for beginning proceedings for taxation.

Rule 5 prescribes the procedure for taxation of the costs of any matrimonial proceedings.

Rule 6 provides that any communications addressed to the taxing master are to be sent to the appropriate office, i.e., in relation to proceedings in the High Court, the Supreme Court taxing office and, in relation to proceedings in a divorce county court, the county court office serving that court

Rule 7 provides that the taxation of the costs of matrimonial proceedings are to be in accordance with the matrimonial scale, as set out in the Appendix to the Rules.

Rule 8 makes provision for the assessment of any costs of a litigant in person in any matrimonial proceedings in a divorce county court.

Rule 9 enables fixed costs to be allowed in an undefended cause at the option of the petitioner's solicitor.

Rule 10 makes provision for the payment of costs within 7 days after the order for payment is made by the registrar pursuant to the taxing master's certificate.

Rule 11 extends the provisions of Order 62, rule 8 of the Rules of the Supreme Court (Northern Ireland) 1980 (which deals with the personal liability of a solicitor for costs) to proceedings in a divorce county court.

Rule 14 extends to proceedings in a divorce county court, those provisions of the Legal Aid, Advice and Assistance (Northern Ireland) Order 1981 which provide that the sums allowed to counsel and a solicitor in connection with proceedings in the House of Lords or the Supreme Court shall be 90% of the amount allowed on taxation of the costs and on account of profit costs, respectively.

The remaining rules contain minor or consequential provisions.

Notice is hereby given that the Lord Chancellor, in pursuance of Article 54 of the Matrimonial Causes (Northern Ireland) Order 1978, has made a Statutory Rule entitled the Matrimonial Causes Rules (Northern Ireland) 1981.

These Rules, which come into operation on 1st September 1981, replace the Matrimonial Causes Rules (Northern Ireland) 1979 and make provision for the procedure on the coming into operation of the Divorce County Courts Order (Northern Ireland) 1981.

While reproducing much of the former procedure the Rules make some important changes. Apart from drafting changes the main alterations are as follows:

- 1. The petition and other documents may be presented at any county court office, or at the office of the chief clerk at Enniskillen, for transmission to the Matrimonial Office for filing (rule 10(5)).
- 2. Provision is made for a person who intends to defend the proceedings to give notice of intention to defend instead of entering an appearance, as hitherto (rule 15).
 - 3. References to "judge" mean:
- (a) in relation to proceedings in the High Court, a judge of the High Court; and
- (b) in relation to proceedings in a divorce county court, a county court judge (rule 2(1)).

- 4. References to "registrar" mean:
- (a) in relation to proceedings in the High Court, the Master (Probate and Matrimonial) or Registrar (Probate and Matrimonial); and
- (b) in relation to proceedings in a divorce county court, a circuit registrar (rule 2(1)).
- 5. A Master's certificate that the pleadings and proceedings are in order will no longer be required but a party requesting the entry of a cause for hearing must lodge in the Matrimonial Office a certificate that the cause is ready for trial (rule 32).
- 6. When the certificate of readiness has been lodged, the cause is deemed to have been set down for trial (rule 35).
- 7. Medical and other expert evidence or the evidence of an inquiry agent to prove adultery may without leave, and in an undefended cause must, be given by affidavit (rule 44(6)).
- 8. Provision is made for an appeal from a judge in divorce county court proceedings, to the Court of Appeal (rule 97) and for an appeal from the registrar in divorce county court proceedings to a county court judge (rule 98).

THE POST OFFICE INLAND POST AMENDMENT (No. 6) SCHEME 1981

Made	19th June 1981
Coming into operation	6th July 1981

The Post Office, by virtue of the powers conferred upon it by section 28 of the Post Office Act 1969, and all other powers enabling it in this behalf, hereby makes the following Scheme:

Commencement, citation and interpretation

- (1) This Scheme shall come into operation on 6th July 1981 and may be cited as the Post Office Inland Post Amendment (No. 6) Scheme 1981.
 - (2) This Scheme shall be read as one with the Post Office Inland Post Scheme 1979 (Post Office Scheme P1/1979) (hereinafter called "the Scheme") as amended by the Post Office Inland Post Amendment (No. 1) Scheme 1979 (Post Office Scheme P5/1979), the Post Office Inland Post Amendment (No. 2) Scheme 1980 (Post Office Scheme P1/1980), the Post Office Inland Post Amendment (No. 3) Scheme 1980 (Post Office Scheme P6/1980), the Post Office Inland Post Amendment (No. 4) Scheme 1981 (Post Office Scheme P1/1981) and the Post Office Inland Post Amendment (No. 5) Scheme 1981 (Post Office Scheme P5/1981).
- 2.—(1)(a) In sub-paragraph (1) of paragraph 3 of the Scheme in the definition of "cash on delivery packet" the words "a trade charge" shall be deleted and the words "the cash on delivery amount" inserted in their place.
 - (b) the following definition shall be inserted after the definition of "business reply packet".

- " "cash on delivery amount" has the meaning assigned to it in the following definition of "cash on delivery packet";"
- (c) the following definition shall be inserted after the definition of "customs duty".
- " "Despatch/Inpayment Document" has the meaning assigned to it by paragraph 48;"
- (d) the definition "trade charge", "trade charge form" and "trade charge money order" shall be deleted.

Fees and conditions

- 3.—(1) In sub-paragraph (1) of paragraph 48 of the Scheme the amount "50p" shall be deleted and "60p" inserted in its place.
 - (2) In sub-paragraph (3) of paragraph 48 of the Scheme the words "trade charge" shall be deleted and the words "cash on delivery amount" inserted in their place and the amount "£100" shall be deleted and "£250" inserted in its place.
 - (3) In sub-paragraph (4) of paragraph 48 of the Scheme the words "the trade charge form" shall be deleted and the words "the Despatch/Inpayment Document" inserted in their place.
 - (4) In sub-paragraph (5) of paragraph 48 of the Scheme the words "trade charge form" shall be deleted and the words "despatch/inpayment document" inserted in their place.
 - (5) The following sub-paragraph shall be inserted immediately after sub-paragraph (5) of paragraph 48 of the Scheme
 - "(6) If the sender of a cash on delivery packet wishes enquiries to be made about the delivery of a cash on delivery packet or payment of the relevant cash on delivery amount, he shall complete such forms as the Post Office may prescribe and pay a fee of 60p in respect of each packet under enquiry. The Post Office will refund the fee in those cases it considers appropriate"

Delivery of cash on delivery packets

4. In paragraph 49 of the Scheme the words "trade charge" shall be deleted wherever they occur and "cash on delivery amount" inserted in their place.

Payment of cash on delivery amount to sender

5. The heading to and paragraph 50 of the Scheme shall be deleted and the following shall be inserted in their place

"Payment of cash on delivery amount to sender

50. The Post Office shall upon receiving the cash on delivery amount from the addressee remit the same to the sender of the packet or a person named by him to receive it by such means as the Post Office may think fit."

Trade charge money order - crossing

6. The heading to and paragraph 51 of the Scheme shall be deleted.

Trade charge money orders - payment to bankers

7. The heading to and paragraph 52 of the Scheme shall be deleted.

Payment of out of date money orders

8. The heading to and paragraph 53 of the Scheme shall be deleted.

Cash on delivery packts to and from the Channel Islands or to and from the Isle of Man

- 9.—(1) In sub-paragraph (1) of paragraph 68 of the Scheme the words "a 'trade charge' " shall be deleted and "the 'cash on delivery amount' " inserted in their place.
 - (2) Sub-paragraph (2) of paragraph 68 of the Scheme shall be deleted.
