DEPARTMENT OF EDUCATION

Notice is hereby given that the Department of Education in exercise of the powers conferred on it by Articles 11 and 14 of and Schedule 3 to the Superannuation (Northern Ireland) Order 1972 and of all other powers enabling it in that behalf, has made a Statutory Rule entitled — Teachers' Superannuation (Notional Salaries) Regulations (Northern Ireland) 1982: (SR 1982 No. 12).

The purpose of this Rule is to substitute Notional Salaries derived from the "Clegg" (Standing Commission on Pay Comparability) Award in order that teachers who retired during the period affected by the award would receive the benefit of the full award.

DEPARTMENT OF HEALTH AND SOCIAL SERVICES

Notice is hereby given that the Department of Health and Social Services, in exercise of powers conferred by Articles 12 and 14 of the Superannuation (Northern Ireland) Order 1972, has made regulations entitled the Health Services (Superannuation) (War Service, etc.) (Amendment) Regulations (Northern Ireland) 1982 (SR 1982 No. 14). The regulations were made on 18th January 1982 and come into operation on 15th March 1982.

These regulations amend the Health Services (Superannuation) (War Service, etc.) Regulations (Northern Ireland) 1978 which provide for the war service of certain members of the Health and Personal Social Services Superannuation scheme to count at half its length for the purpose of calculating superannuation benefits payable to or in respect of them.

A person who was unable to have his war service reckoned for benefit purposes because he transferred from the Health and Personal Social Services superannuation scheme to certain other schemes before 17th July 1975, will, subject to certain conditions, be able to have his reckonable war service transferred to that scheme. Similarly a member of the Health and Personal Social Services superannuation scheme may have his reckonable war service transferred from another scheme to the Health and Personal Social Services superannuation scheme where a transfer payment is made to the Department. Certain officers who were in public health services employment following war service but were previously excluded from the Health Services (Superannuation) (War Service, etc.) Regulations (Northern Ireland) 1978 may now make application under those regulations to have their war service reckoned for benefit purposes.

DEPARTMENT OF MANPOWER SERVICES

Notice is hereby given that in pursuance of powers conferred on it by Articles 70 and 80(3) of the Industrial Relations (Northern Ireland) Order 1976 and Articles 5(5) and 63(4) of the Industrial Relations (No. 2) (Northern Ireland) Order 1976, the Department of Manpower Services has made an Order entitled the Industrial Relations (Variation of Limits) Order (Northern Ireland) 1982 (SR 1982 No. 22).

This Order, which comes into operation on 1st February 1982 varies certain of the limits under the Contracts of Employment and Redundancy Payments Act (Northern Ireland) 1965 ("the Act of 1965"), the Industrial Relations (Northern Ireland) Order 1976 ("the No. 1 Order), and the Industrial Relations (No. 2) (Northern Ireland) Order 1976 ("the No. 2 Order"). The limit on the amount of "a week's pay" for the purposes of calculating a redundancy payment under the Act of 1965 and the basic and additional awards of compensation for unfair dismissal under the No. 1 Order is increased from £130 to £135. The limits on the amount for the purpose of calculating the sum payable by the Department under Article 42 of the No. 1 Order in respect of debts due to an employee whose employer becomes insolvent is likewise increased from £130 to £135. The limit on the amount of a guaranteed payment payable under Article 5(1) of the No. 2 Order in respect of any day is increased from £8.75 to £9.15.

Notice is hereby given that in pursuance of powers conferred on it by Articles 37(2) and 80(3) of the Industrial Relations (Northern Ireland) Order 1976, the Department of Manpower Services has made an Order entitled the Unfair Dismissal (Increase of Compensation Limit) Order (Northern Ireland) 1982 (SR 1982 No. 23).

This Order, which comes into operation on 1st February 1982, increases from £6,250 to £7,000 the limit on the amount of compensation which can be awarded by an industrial tribunal in claims for unfair dismissal as the compensatory award or as compensation for failure fully to comply with the terms of an Order for reinstatement or re-engagement.

This Order revokes in whole the Unfair Dismissal (Increase of Compensation Limit) (No. 2) Order (Northern Ireland) 1979 (SR 1979 No. 455).
