THE POST OFFICE OVERSEAS LETTER POST AMENDMENT (No. 1) SCHEME

9th September, 1982

Coming into operation

13th September, 1982

The Post Office, by virtue of the powers conferred upon it by Section 28 of the Post Office Act 1969, and of all other powers enabling it in this behalf, hereby makes the following Scheme:

Commencement and Citation

1.—(1) This Scheme shall come into operation on the 13th day of September 1982, and may be cited as the Post Office Overseas Letter Post Amendment (No. 1) Scheme 1982.

(2) This Scheme shall be read as one with the Post Office Overseas Letter Post Scheme 1982 (Post Office Scheme P2/1982) (hereinafter called "the Scheme").

Interpretation

2. For the meaning of "insured letter" in sub-paragraph (1) of paragraph 3 of the Scheme there shall be substituted the following:

"insured letter" means any letter which is for the time being transmissible as an insured letter under the provisions of the Universal Postal Union Convention for the time being in force, and the Detailed Regulations made thereunder;"

Prohibitions

3. The words "without prejudice to the application of paragraph 3(5)" in paragraph 11(3)(c) of the Scheme are hereby deleted.
