#### DISEASES OF ANIMALS (IMPORTATION OF POULTRY) ORDER (NORTHERN IRELAND) 1965

##### *Open General Licence*

The Department of Agriculture in accordance with the provisions of the above Order hereby licenses the Importation from the Republic of Ireland of eviscerated poultry carcasses provided:

1. Each consignment originates from an EEC approved slaughterhouse or processing plant.
2. Each consignment shall have identification marks identifying the slaughtering premises of origin and these shall appear on the carton or case containing the carcass and also on the weight docket of each carcass.
3. Each consignment is accompanied by a valid veterinary certificate issued by the Department of Agriculture, Dublin, in accordance with the terms of EEC/71/118.

This licence shall remain in operation until revoked by the Department of Agriculture. The licence issued on 13th January, 1984, is hereby revoked.

### LANDING OF CARCASSES AND ANIMAL PRODUCTS ORDER (NORTHERN IRELAND) 1970 AS AMENDED

#### OPEN GENERAL LICENCE

*Animal Health Requirements for Importation of Sterilized Milk, Sterilized Cream and Sterilized Milk Based Drinks from Listed Member States of the European Community*

The Department of Agriculture for Northern Ireland hereby authorises the landing at Belfast port of consignments of sterilised milk, sterilised cream and sterilised milk based drinks moved direct from listed Member States\* of the EC subject to the following conditions:

1. Sterilised milk, cream, milk based drinks must have been processed as follows:
  - (a) a temperature of at least 108°C for at least 45 minutes; or
  - (b) a temperature of at least 110°C for at least 30 minutes; or
  - (c) a temperature of at least 112°C for at least 18 minutes; or
  - (d) a temperature of at least 115°C for at least 10 minutes.
2. Each consignment must be accompanied by an Animal Health Certificate signed by an official veterinarian of the Veterinary Service of the Member State of origin certifying that the products have been subject to one of the processes outlined at condition 1 above.
3. This certificate must give details of the consignment, description of product, name and address of factory of origin, quantity, consignor/consignee, final place of destination.
4. Two working days notice of arrival of each consignment in Northern Ireland must be given to the Portals Supervisor, Crown Buildings, 5A Frederick Street, Belfast (Telephone Belfast 244711, Ext. 296 or 297 or Belfast 221950).
5. The Animal Health certificate must be presented to an Imports Inspector of the Department immediately on arrival at the place of entry into Northern Ireland. The consignment must not be removed from the place of entry until cleared by the Inspector.
6. Importations must comply with the requirements of the Importation of Milk Regulations (Northern Ireland) 1983 and any other relevant legislation.

This licence shall come into effect on 5th March, 1984,

and remain in operation until revoked by the Department. The licence issued on 17th November, 1983, is hereby revoked.

*Animal Health Requirements for Importation of UHT Milk, UHT Cream and UHT Milk Based Drinks from Listed Member States of the European Community.*

The Department of Agriculture for Northern Ireland hereby authorises the landing at Belfast port of consignments of UHT milk, UHT cream and UHT milk based drinks moved direct from listed Member States\* of the EC subject to the following conditions:

1. UHT Milk, cream, milk based drinks must have been processed at a temperature of at least 135°C for at least 1 second.
2. Each consignment must be accompanied by an Animal Health certificate signed by an official veterinarian of the Veterinary Service of the Member State of origin certifying that the products have been subject to the process outlined at condition 1 above.
3. This certificate must give details of the consignment, description of product, name and address of factory of origin, quantity, consignor/consignee, final place of destination.
4. Two working days notice of arrival of each consignment in Northern Ireland must be given to the Portal Supervisor, Crown Buildings, 5A Frederick Street, Belfast (Telephone Belfast 244711 Ext. 296 or 297 or Belfast 221950).
5. The Animal Health certificate must be presented to an Imports Inspector of the Department immediately on arrival at the place of entry into Northern Ireland. The consignment must not be removed from the place of entry until cleared by the Inspector.
6. Importations must comply with the requirements of the Importation of Milk Regulations (Northern Ireland) 1983 and any other relevant legislation.

The Department of Agriculture for Northern Ireland hereby authorises the landing at Belfast, Larne, Warrenpoint and Londonderry ports and Belfast International and Belfast Harbour airports of consignments of dried milk products moved direct from Netherlands, Belgium, Canada, France, Norway, USA, Denmark, West Germany and Luxembourg subject to the following conditions:

1. Each consignment must be accompanied by a certificate signed by a duly authorised Veterinary Officer of the

Government of the country in which the dried milk products originated stating that:

(a) during processing the milk has been subjected to heat treatment at:

- (i) a minimum temperature of 60°C for a period of at least 30 minutes; or
- (ii) a minimum temperature of 75°C for a period of at least 12 seconds; or
- (iii) a minimum temperature of 77°C for a period of at least 5 seconds;

(b) after the heat treatment has been completed the milk was spray/roller dried;

(c) after completion of the drying process every precaution was taken to prevent contamination of the product; and

(d) the final product was packed in new containers.

2. The certificate specified at condition 1 above must be presented to one of the Department's Imports Inspectors at the point of entry.

3. Importations must comply with the requirements of the Imported Food Regulations (N.I.) 1968 as amended and any other relevant legislation.

4. Two working days notice of arrival of each consignment in Northern Ireland must be given to the Portal Supervisor, Crown Buildings, 5A Frederick Street, Belfast (Telephone Belfast 244711 Ext. 296 or 297 or Belfast 221950).

This licence shall come into effect on 5th March, 1984, and remain in operation until revoked by the Department.
