### THE IMPORTED FOOD (NORTHERN IRELAND) REGULATIONS 1968

#### *Yugoslavia: Official Certificate*

The Department of Health and Social Services with the approval of the Minister of Agriculture, Fisheries and Food and the Secretary of State for Wales gives notice that, in exercise of the powers conferred on it by the Imported Food (Northern Ireland) Regulations 1968 as amended by the Imported Food (Northern Ireland) (Amendment) Regulations 1973, 1979 and 1981, it hereby recognises, subject to the conditions hereinafter set out, the Official Certificates described in Part 1 of the Schedule hereto for the importation from Yugoslavia of meat and meat products and poultry meat and poultry meat products as showing:—

- (a) that the meat or poultry meat to which they relate, or the meat or poultry meat from which the meat product to which they relate was prepared, was derived from mammals or poultry inspected before and after death in the country of origin of the meat and passed in accordance with criteria satisfactory to the Ministers; and
- (b) that the dressing, packing and other preparation of the meat or poultry meat was carried out with all necessary precautions for the prevention of danger to health.

1. Recognition of the Official Certificate is extended to include:—

- (a) meat, with or without bone, which contains no associated lymphatic glands, or from which any pleura, peritoneum or lymphatic gland has been removed; and
- (b) portions of carcasses with or without bone, comprising recognisable wholesale or retail cuts which contain no associated lymphatic gland or from which has been removed, in preparing or trimming the meat, any pleura, peritoneum or lymphatic gland.

The recognition does not extend to boneless veal appearing to an authorised officer to be from calves less than three months old.

2. The said Official Certificates are recognised subject to the following conditions :—

- (i) Recognition applies only to meat and meat products or poultry meat or poultry meat products imported from Yugoslavia but does not apply to any such meat or meat products derived from mammals or poultry killed when wild.
- (ii) Where the Official Certificate is in the form of a stamp or label, recognition will apply only if the stamp or label is securely marked or affixed to the meat or to packages of meat products as well as to any container in which the meat or meat products are packed and if the stamp or label has not in any other circumstances or on any other occasion been used as an Official Certificate.

Recognition of the Official Certificates is restricted to the extent shown in the Schedule hereto.

The Notices published in the Belfast Gazette dated 4 June, 1982, 11 December, 1981, 2 August, 1968, and in the London Gazette on 9 September, 1955, are hereby revoked.
