### MISUSE OF DRUGS ACT 1971, SECTION 12

Direction Prohibiting Exercise of Powers in Relation to Controlled Drugs

In accordance with section 12(4) of the Misuse of Drugs Act, 1971, notice is hereby given that the Secretary of State gave the following direction which came into force on 27th June, 1984:

"Whereas William James Collins, M.P.S., a pharmacist within the meaning of the Misuse of Drugs Act, 1971, whose registered address is 5 Chatham Avenue, St. Anne's on Sea, Lancashire, was on 26th March, 1984, convicted of certain offences under the Misuse of Drugs Act, 1971.

Now, therefore, in pursuance of section 12(2) of the Misuse of Drugs Act, 1971, I hereby direct that the said William James Collins be prohibited from having in his possession, manufacturing, compounding and supplying and from supervising and controlling the manufacture, compounding and supply of any con-trolled drug within the meaning of that Act.

This Direction does not extend to the doing of anything in circumstances in which it might lawfully be done without being a pharmacist."

## INDEX LINKED ULSTER SAVINGS CERTIFICATES

### RETIREMENT AND SECOND INDEX LINKED ISSUES

Movement of the United Kingdom General Index of Retail Prices

For the purpose of revaluing on repayment of Index Linked Ulster Savings Certificates of the Retirement and Second Index Linked Issues in accordance with the relevant Ulster Savings Certificates Regulations the Index figure issued by the Department of Employment in the month of July, 1984, and applicable to the month of August, 1984, is 351.9.

## ULSTER SAVINGS CERTIFICATES (AMENDMENT) **REGULATIONS 1984**

The Department of Finance and Personnel has made regulations—Statutory Rule 1984, No. 238—entitled Ulster Savings Certificates (Amendment) Regulations 1984 in-creasing from £1,500 to £5,000 the limit in Regulation 25 of the Ulster Savings Certificates Regulations 1962 on the amount of Ulster Savings Certificates which may be repaid Grant of Probate or Letters of Administration. The in-crease to £5,000 shall apply in relation to deaths occurring on or after 1st August, 1984.

#### SUPPLEMENTS

The Department of Finance and Personnel has made regulations-Statutory Rule 1984, No. 248-entitled Ulster Savings Certificates (Index Linked) (Supplement) Regulations 1984, to provide for a supplement to be paid on Ulster Savings Index Linked Certificates as follows:---

An index linked certificate held at 31st October, 1983, and still held at 31st October, 1984, will have a supplement of 2.4% of the index linked value of that certificate at 31st October, 1983, added to the amount repayable on or after 1st November, 1984. If the certificate continues to be held the supplement will be indexed until month of removiment repayment.

An index linked certificate purchased in or after Nov-ember, 1983, but before October, 1984, will have a supplement of 0.2% of the purchase price for each whole calendar month from month of purchase up to the end of October, 1984, added to the amount repayable on or after the first anniversary of purchase of that certificate. If the certificate is held beyond the first anniversary of purchase the supplement will be indexed until month of repayment.

The supplement is additional to any index increase, bonus or supplement already payable on a certificate.
