#### MISUSE OF DRUGS ACT 1971: SECTION 12(4)

*Suspension of Direction Prohibiting Exercise of Powers in Relation to Controlled Drugs*

### DEPARTMENT OF AGRICULTURE FOR NORTHERN IRELAND

THE FERTILISERS (AMENDMENT) REGULATIONS (NORTHERN IRELAND) 1984

Notice is hereby given that the Department of Agriculture for Northern Ireland in exercise of the powers conferred on it by Section 66(1), 68(1), (2) and (3), 69(1), (3), (6) and (7), 70(1), 74(1), 74A(1), (2) and (4), 84 and 86 of the

Agriculture Act 1970 and of every other power enabling it in that behalf, has made on 22nd October, 1984 the Fertilisers (Amendment) Regulations (Northern Ireland) 1984 (SR 1984 No. 363).

The regulations will come into operation on 18th April, 1985.

These Regulations which implement Articles 1, 2, 3 and 6 of the Council Directive 80/876 EEC, amend the Fertilisers Regulations (Northern Ireland) 1977. They provide specifications for the composition and characteristics of straight ammonium nitrate fertilisers containing more than 28% nitrogen and sold as "EEC fertilisers," and provide for such products to be made available for final use as fertilisers only when packaged.

Similar regulations have been made in Great Britain.
