I, the Right Hon. Sir Richard Dawson Bates, Minister of Home Affairs for Northern Ireland, being the Civil Authority under the Civil Authorities (Special Powers) Act (Northern Ireland), 1922, by virtue of the powers vested in me by the said Act and the Regulations made thereunder, and of all other powers enabling me in this behalf do Hereby Order and Require that within the County of the City of Belfast all Licensed Public-houses and Spirit Groceries shall be Closed except between the hours of 12 o'clock noon and 7 o'clock p.m.

Provided that this Order shall not be deemed to authorise such houses or premises to be opened or kept open except during the hours now permitted by law.

Provided also that this Order shall not apply to any Licensed Premises which are structurally adapted to be used and bona-fide used for the purpose of the reception of guests and travellers desirous to sleep in the premises, or which are Licensed Premises structurally adapted for use, and bona-fide used as a restaurant.

And I do further Order and Require that every person within the said area shall remain within doors between the hours of 10 o'clock p.m. and 6 o'clock a.m., unless provided with a Permit in writing from the Commissioner of Police for the City of Belfast, or some person duly authorised by him.

Provided that this Order shall not be deemed to vary or relax any of the provisions of the Order made by me on 13th May, 1922, with respect to the area specified therein, and the said Order of 13th May, 1922, shall remain of full force and effect.

This Order shall come into force at 7 p.m. on this date.
