NATIONAL HEALTH INSURANCE ACTS, 1924 TO 1928.

NOTICE is hereby given under Section 94 of the National Health Insurance Act, 1924, as extended by the National Health Insurance Act, 1928, as applied to Northern Ireland by the National Health Insurance Act (Northern Ireland), 1928, and the National Health Insurance (Extension of Enactments) Order

(Northern Ireland), 1928, made thereunder, that it is proposed by the National Health Insurance Joint Committee, with the approval of the Ministry of Finance for Northern Ireland, after the expiration of at least 21 days from this date, and in exercise of the powers conferred upon them by the proviso to Sub-section (2) of Section 1 of the National Health Insurance Act, 1924, and by Paragraph (1) of Article 5 of the National Health Insurance (Joint Committee) Regulations, 1924, to make a Special Order amending the National Health Insurance (Subsidiary Employments) Consolidated Order (Northern Ireland), 1925;

And that on account of urgency the National Health Insurance Joint Committee, with the approval of the Ministry of Finance for Northern Ireland, under Sub-section (7) of Section 94 of the National Health Insurance Act, 1924, as extended as aforesaid, propose to make a provisional Special Order entitled the National Health Insurance (Subsidiary Employments) Amendment Order (Northern Ireland), 1930, to come into force immediately as a provisional Special Order, to continue in force until a Special Order has come into force in accordance with the provisions of Section 94 of that Act.
