MONOPOLY REFERENCE :

The Supply of Marine Navigation Receivers

The Director General of Fair Trading in exercise of his powers under section 47(1), 49(1) and 50(1) of the Fair Trading Act 1973 hereby refers to the Monopolies and Mergers Commission the matter of the existence or possible existence of a monopoly situation in relation to the supply in the United Kingdom of marine radio navigation receivers which are compatible with the Decca Navigation System ("DNS").

The Commission shall upon this reference investigate and report in relation to such supply on the questions whether a monopoly situation exists and, if so :

- (1) by virtue of which provision of section 6 of that Act that monopoly situation is to be taken to exist ;
- (2) in favour of what person or persons that monopoly situation exists ;
- (3) whether any steps (by way of uncompetitive practices or otherwise) are being taken by that person or those persons for the purpose of exploiting or maintaining the monopoly situation and, if so, by what uncompetitive practices or in what other way ;
- (4) whether any action or omission on the part of that person or those persons is attributable to the existence of the monopoly situation and, if so, what action or omission and in what way it is so attributable ; and
- (5) whether any facts found by the Commission in pursuance of these investigations operate, or may be expected to operate, against the public interest.

In this reference :

"THE DNS" means the hyperbolic marine radio navigation system operated by Racal Decca Navigator Limited and comprising a series of land-based radio transmission stations and

"A marine radio navigation receiver compatible with the DNS" means a radio navigation receiver designed to enable a marine vessel to determine its position using the radio signals which it receives from those land-based radio transmission stations which form part of the DNS.

The Commission shall report on this reference within a period of eighteen months from the date hereof.

THE HOUSING (NORTHERN IRELAND) ORDER 1985

This Order makes further provision with respect to housing in Northern Ireland.

Part 1 is introductory.

The purpose of the Order is to facilitate the provision of financial assistance to certain private owners of dwell-

ings in Northern Ireland which have been sold by the Northern Ireland Housing Executive or certain other public bodies and which are defective by reason of their design or construction and which, as a result of those defects having become generally known, have been substantially reduced in value. The assistance is to be provided to eligible owners of defective dwellings, in the form of reinstatement grant or, in certain circumstances, by repurchase of the owner's interest in the dwelling, if the owner wishes. On such repurchase the owner of the dwelling, or in certain circumstances his tenant, is entitled to require the granting of a secure tenancy by the Executive.

The Order extends the circumstances under which a secure tenant of the Executive has the right to buy his home and amends other rights of secure tenants under the Housing (Northern Ireland) Order 1983.

This Order contains provisions of a miscellaneous and supplemental nature.
