THE MINISTRY OF HOME AFFAIRS FOR NORTHERN IRELAND.

RURAL DISTRICT OF NEWRY No. 1.

To the Council of the Administrative County of Down;

To the Council of the Newry No. 1 Rural District;

And to all others whom it may concern:

WHEREAS, by Section 1 of the Public Health (Ireland) Act, 1896, as adapted, it is enacted in effect that the Ministry of Home Affairs for Northern Ireland (hereinafter referred to as "the Ministry"), may, on the application of the sanitary authority of any rural district, by order to be published in the "Belfast Gazette," or in such other manner as the said Ministry may direct, declare any provisions of the Public Health (Ireland) Acts, 1878 to 1890, in force in Urban Districts to be in force in such Rural District or any contributory place therein, and may invest such authority with all or any of the powers, rights, duties, capacities, liabilities, and obligations of an Urban Authority under these Acts; and that such investment may be made either unconditionally or subject to any conditions to be specified by the Ministry as to the time, portion of the district, or manner, during at, and in which such powers, rights, duties, liabilities, capacities and obligations are to be exercised and attach;

And Whereas it is enacted by Section 22 of the Local Government (Ireland) Act, 1898, that all Urban Sanitary Authorities shall becalled Urban District Councils, and that for every Rural Sanitary District there shall be a Rural District Council, whose district shall be called a Rural District;

And Whereas it is enacted by sub-section (1) of section 33 of the said Local Government Act that there shall be transferred to the District Council of any Rural District the business of the Rural Sanitary Authority in the District:

And Whereas it is enacted in effect by Section 232 of the Public Health (Ireland) Act, 1878, as adapted, that special expenses (as defined in the said Section 232) shall be (amongst others) the expenses of lighting where duly authorised; that special expenses shall be a separate charge on some contributory place or places; that such portion of any townland or townlands as may be determined by the Ministry shall be a contributory place; that the said Ministry shall have power to determine on what area of charge, being a contributory place or consisting of contributory places, any special expenses shall be chargeable;

And whereas the Council of the Newry No. 1 Rural District (hereinafter referred to as "the Council") have made application to the Ministry under the said Section 1 of the Public Health (Ireland) Act, 1896, for an Order declaring the provisions of Section 49 of the said Public Health (Ireland) Act, 1878, in force in Urban Districts to be in force in certain portions of the townlands of Cross, Kiltarriff, Lissize in the Parish of Drumballyroney, Lissize in the Parish of Drumgath and Rossconor;

in the Parish of Drumgath and Rossconor;
Now, Therefore, the Ministry of Home
Affairs for Northern Ireland, in exercise of the
powers vested in it by the Public Health
(Ireland) Acts, 1878 to 1918, as adapted, and
by all other statutes in this behalf enabling the
Ministry, hereby orders, declares and deter-

mines as follows, that is to say:-

1. In this Order the expression "deposited map" means the map executed in triplicate under the Seal of Office of the Local Government Board for Ireland, on the 14th day of February, 1906, in relation to the determination of portions of the said Townlands as a contributory place, a copy of which map as so executed has been deposited at the Office of the Clerk of the Council.

- 2. The respective portions of the Townlands of Cross, Kiltarriff, Lissize in the Parish of Drumballyroney, Lissize in the Parish of Drumgath and Rossconor, which are contained within the boundaries delineated on the deposited map are hereby determined to be a contributory place for the purposes of the Public Health (Ireland) Acts, 1878 to 1918.
- 3. The provisions of Section 49 of the Public Health (Ireland) Act, 1878, are declared to be in force within the limits or boundaries of the said contributory place, and subject to any conditions which the Ministry may hereafter deem fit to specify in the matter and to the provisions as to rating in Rural Districts of the Local Government Acts (Northern Ireland), 1898 to 1929, the Council is hereby invested with all the powers, rights, duties, capacities, liabilities and obligations of an Urban District Council under Section 49 of the Public Health (Ireland) Act, 1878, to be exercised and attach within the said limits or boundaries of the aforesaid area.

4. The said contributory place is hereby determined to be the area of charge upon which all expenses incurred by the Council in carrying out the provisions of Section 49 of the said Public Health (Ireland) Act, 1878, within the said limits or boundaries

shall be chargeable.

MERCHANDISE MARKS ACT, 1926. FROZEN OR CHILLED SALMON AND TROUT.

It is announced that an application for an Order in Council under the above-mentioned Act to require the marking of imported frozen or chilled Salmon and Trout with an indication of origin has been referred for inquiry to the Standing Committee set up under the Act by the Minister of Agriculture and Fisheries, the Secretary of State for the Home Department, and the Secretary of State for Scotland, acting jointly.

Attention is called to the fact that, under the provisions of the Act, while the Committee in every case referred to them must consider whether the goods should bear the indication of origin at the time of sale or exposure for sale, they may also, at their discretion, consider and report upon the question whether such goods should bear an indication of origin at the time of importation.

The date of the Inquiry will be announced later. Any communication with regard to the matter should, however, be addressed, as early
