I, James Albert Edward, Duke of Abercorn, K.G., K.P., Governor of Northern Ireland, in pursuance of the powers vested in me by the Inebriates Acts, 1879 to 1900, and of all other powers me thereunto enabling, Do Hereby Appoint Norman Colum Patrick, M.R.C.S. (Eng.), L.R.C.P. (Lond.), to be Inspector of Retreats established in Northern Ireland under the Inebriates Acts, in the room of Lieutenant-Colonel William Richard Dawson, M.D., O.B.E., resigned, whose appointment as Inspector of Retreats by Warrant, dated the 24th day of February, 1922, is hereby revoked.

APPOINTMENT OF AN INSPECTOR OF LUNATICS IN NORTHERN IRELAND.

MERCHANDISE MARKS ACT, 1926. REPORT OF THE STANDING COMMITTEE BROOMS AND BRUSHES.

With reference to the notice which was published in the London, Edinburgh and Belfast "Gazettes" of the 15th November, 1929, regarding a reference made by the Board of Trade to the Standing Committee under the Merchandise Marks Act, 1926, in respect of imported brooms and brushes of all descriptions other than tooth brushes, shaving brushes and brushes for oil and water colour painting of the types used by artists and students, the Board of Trade hereby give notice, in accordance with the provisions of Section 2, Sub-section 7, that a Report has been made by the Committee in respect of the aforesaid classes and descriptions of goods.
