PRESENT,

The KING'S Most Excellent Majesty in Council.

WHEREAS by section sixty-nine of the Government of Ireland Act, 1920, His Majesty is empowered by Order in Council to make such regulations as seem necessary or proper for setting in motion the Parliaments and Governments of Southern and Northern Ireland, and also for any other matter for which it seems to His Majesty necessary or proper to make provision for the purpose of any of the provisions of the said Act, and in particular His Majesty is empowered amongst other things, by any such Order in Council, to provide, where the day appointed for the transfer of any Irish service is subsequent to the day appointed as the day upon which the Irish residuary share of reserved taxes became payable, for the proper deductions in respect of the cost of that service during the interval between the said days:

And whereas the day appointed as the day on which the Irish residuary share of reserved taxes became payable as respects Northern Ireland was the 22nd day of November, 1921, and subsequent days, namely, the 1st day of December, 1921, the 1st day of January, 1922, the 1st day of February, 1922, and the 1st day of March, 1922, were, by Orders in Council made under the said Act on the 9th day of November, 1921, and the 22nd day of December, 1921, fixed to be the appointed days as respects Northern Ireland for the transfer of the respective Irish services in the said Orders mentioned:

And whereas by the Provisional Government (Council of Ireland) Order, 1922, being an Order in Council made under section one of the Irish Free State (Agreement) Act, 1922, it is provided that the appointed day for the purposes of the provisions of the Government of Ireland Act, 1920, with respect to the powers of the Council of Ireland shall as respects Northern Ireland be such day as may hereafter be fixed by Order in Council, not being earlier than the day of the first meeting of the Parliament of the Irish Free State, and no day has as yet been fixed under the said Order:

And whereas the provisions of section 1 of the Rules Publication Act, 1893, have been complied with:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

1.—(1) This Order may be cited as the Government of Ireland (Cost of Services pending Transfer) Order, 1922.

(2) The Interpretation Act, 1889, applies to the interpretation of this Order in like manner as it applies to the interpretation of an Act of Parliament.

2. Where the day appointed as respects Northern Ireland for the transfer of any Irish service is a day subsequent to the 22nd day of November, 1921, the cost of that service as respects Northern Ireland during the interval between the 22nd day of November, 1921, and the appointed day shall be determined by the Joint Exchequer Board, and the amount so determined shall be deducted from the sum payable to the Exchequer of Northern Ireland in respect of the Irish residuary share of reserved taxes.
