ABERCORN.

In pursuance of the powers conferred upon me by the Wild Birds Protection Act, 1894, the Government of Ireland Act, 1920, and the several Statutes and Orders in that behalf, and upon the application by the County Council of the County of Armagh, I do hereby make the following Order:—

The taking or destroying of the Eggs of the following species of Wild Birds is between the 1st day of March and the 1st day of August of each year prohibited throughout the Administrative County of Armagh for the space of five years from the 1st day of March, 1931:---

- Buzzard, Chough, Greenfinch, Great-Crested Grebe, Harrier, Kingfisher, Peregrine-Falcon, Raven, Siskiu, Skylark, Tern (all species), Owl (all species), Lapwing (Peewit or Green Plover), Wild Duck.
- Given at Government House, Hillsborough, Northern Ireland, this 14th day of March, 1931.

RETURNING OFFICERS' CHARGES.

The Ministry of Finance hereby gives Notice, pursuant to Section 1 (3) of the Rules Publication Act (Northern Ireland), 1925, that by virtue of the powers conferred upon it by Section 29 of the Representation of the People Act, 1918, an Order (dated 23rd February, 1931) has been made by the Ministry prescribing the scale of maximum charges of Returning Officers at Elections of Members to the House of Commons of Northern Ireland.

REGULATIONS respecting an Open Competition for not less than Three Appointments as Temporary Junior Assistants. (Male) in the Ordnance Survey Office, Ministry of Agriculture, to be held in Belfast (and other Centres if sufficient Candidates are available) on the 29th of April, 1931.

 A candidate must be 15 years of age or upwards and under 16 on the 31st March, 1931.
A candidate must be—

- (a) a natural-born British subject, and
- (b) the son of a father who is a naturalborn British subject.
