- 2. On arrival at the port/airport of landing each consignment must be presented to an Imports Inspector of the Department.
- (i) Any consignment to which this licence relates must be made available at the port/airport of landing between the hours of 0900 and 1700 Monday to Friday for sampling by an authorised officer of the Department of Agriculture;
 - (ii) Consignments must not be moved from the port/airport of landing until sampled and negative results for Salmonella spp have been obtained;
 - (iii) The importer or his agent shall afford all assistance necessary to such an officer to enable him to carry out the inspection/sampling;
