DRAINAGE DIVISION

Ward Park Stream Bangor Drainage Scheme - Phase II

The Department of Agriculture for Northern Ireland hereby gives Notice in pursuance of Article 12 of the Drainage (Northern Ireland) Order 1973 that a scheme has been prepared for the improvement of the Ward Park Stream, Second Phase.

This phase of the Scheme commences at the Gransha Road and continues downstream to meet Phase I at the outlet of the downstream pond adjacent to the library.

The Scheme includes the construction of a pre-cast concrete box culvert from Gransha Road to the existing twin pipe culvert in Ward Park crossing the Fairfield Road. A supplementary box culvert will be laid parallel to the existing twin pipe culvert. A new box culvert will run from the existing twin pipes to the first footbridge at

Gransha Road, after which a new and enlarged open channel will be created between the Gransha Road and the tennis courts within the park. Alterations to the pond, bridges and modifications to the oil collector will also take place.

CATERING WAGES COUNCIL (NORTHERN IRELAND)

The Catering Wages Council (Northern Ireland) hereby gives notice of its intention to publish Proposals for fixing statutory minimum remuneration in substitution for the statutory minimum remuneration fixed by the current Wages Regulation Order relating to workers in respect of whom the Wages Council operates.

The Council proposes that from 23rd June, 1991, the minimum rate of pay for workers aged 21 years and over will be:

Basic rate:

Payable for all time worked up to 39 hours in any week —
£2.78 per hour.

Overtime rate:

Payable for all time worked in excess of 39 hours in any week —
£4.17 per hour.

The Wages Council will consider any written representations with respect to the above-mentioned Proposals which may be sent to it within twenty-eight days from 1st March, 1991. THE ROAD TRAFFIC (AMENDMENT) (NORTHERN IRELAND) ORDER 1991 No. 197 (NI 3) Price £6.95

This Order amends the law relating to road traffic in Northern Ireland.

Part II deals with the licensing of drivers of motor vehicles. Article 3 and Schedule 1 substitute a new Part II of the Road Traffic (Northern Ireland) Order 1981 containing general provisions with respect to driver licensing. Article 4 abolishes the requirements for additional licences for the drivers of public service vehicles and heavy goods vehicles from a day to be appointed under Article 1(2), but preserves the right of holders of such licences granted before that day, during their currency. Schedule 2 lays down requirements applying to existing holders of such licences and sets out certain transitory provisions. Article 5 and Part I of Schedule 3 introduce as new Articles 70 to 79 of the Road Traffic (Northern Ireland) Order 1981 special provisions governing the licensing of drivers of goods vehicles and passenger-carrying vehicles supplemental to the requirements of Part II of that Order. Article 6 and Part II of Schedule 3 provide with respect to the licensing of taxis. Under Article 7 a person learning to drive a motor cycle is required to

complete successfully a course of training before taking a test of competence and is restricted to driving in the course of training until he has successfully completed such a course.

Part III makes fresh provisions with respect to offences arising out of driving, or being in charge of, a motor vehicle while under the influence of drink or drugs.

The Order also makes new provision for financing the practices of medical practitioners and amends the 1972 Order in relation to the provision of accommodation by Boards and the administration of general health services.
