#### CRIMINAL INJURIES COMPENSATION

Notice is hereby given that the Secretary of State in pursuance of paragraph (1) of Article 23 of the Criminal Injuries (Compensation) (Northern Ireland) Order 1988 made on 22nd February, 1991 a Statutory Rule entitled: Criminal Injuries (Compensation) (Northern Ireland) Order 1988 (Amendment) Order 1991.

The purpose of the Order is to increase from £3,500 to £7,500 the maximum amount payable for bereavement, where the victim of a criminal injury, sustained on or after 1st April, 1991, dies as a result of the injury. The compensation for bereavement is payable to the spouse of a victim, or to the parents where the victim is a child under 18; it is in addition to any other compensation which may be paid.

##### General Notice No. 36

#### REFUNDS IN RESPECT OF CONSUMER CREDIT LICENCE APPLICATIONS

I, Gordon Johnson Borrie, Director General of Fair Trading, with the approval of the Secretary of State for Trade and Industry and the Treasury hereby give general notice pursuant to section 2 of the Consumer Credit Act 1974 that:

From 28th March, 1991, refunds in respect of applications for standard, variation, and renewal licences under the Consumer Credit Act 1974 will only be made where:

1. There is an overpayment of fees;
2. Applicants applied for licences which were unnecessary or inappropriate due to OFT error or incorrect information.

It follows that refunds will no longer routinely be made where applications are withdrawn or made of no effect or current licences are surrendered.

#### POST OFFICE SCHEME L2/1991

**NOTE:** The scheme which follows this note is made under Section 28 of the Post Office Act 1969 and amends the Post Office Overseas Letter Post Scheme 1982. The Scheme, which comes into operation on the 18th March 1991, revises certain postal charges, introduces a European airmail small packet service and a European airmail printed packet service and abolishes the European airmail newspaper service, the reduced rate printed packet service and the facility for bulk posting in mail bags.

Additionally, the Scheme revises references to air letters, air mail packets, small packets, printed packets and literature for the blind.

The Post Office by virtue of the powers conferred upon it by Section 28 of the Post Office Act 1969 and of all other powers enabling it in this behalf, hereby makes the following Scheme:

#### Commencement and citation

1. —(1) This Scheme shall come into operation on the 18th March 1991 and may be cited as the Post Office Overseas Letter Post Amendment (No. 12) Scheme 1991.
