### NORTHERN IRELAND COURT SERVICE

Notice is hereby given that the Lord Chancellor, in exercise of the powers conferred on him by Articles 6(2), 22(1) and 27 of the Legal Aid, Advice and Assistance (Northern Ireland) Order 1981, has made a Statutory Rule entitled the Legal Advice and Assistance (Prospective Cost) Regulations (Northern Ireland) 1991.

These Regulations, which come into operation on 8th April, 1991, revoke and replace the Legal Advice and Assistance (Prospective Cost) Regulations (Northern Ireland) 1990 to increase from £78.50 to £84.00 the limit on the cost of legal advice and assistance provided under Articles 3 and 4 of the Legal Aid, Advice and Assistance (Northern Ireland) Order 1981, which a solicitor may incur without obtaining the approval of the appropriate authority.

Notice is hereby given that the Lord Chancellor, in exercise of the powers conferred on him by Articles 12(2), 22 and 27 of the Legal Aid, Advice and Assistance (Northern Ireland) Order 1981 has made a Statutory Rule entitled the Legal Aid (Financial Conditions) Regulations (Northern Ireland) 1991.

These Regulations, which come into operation on 8th April, 1991, increase the financial limit of eligibility for legal aid under Part II of the Legal Aid, Advice and Assistance (Northern Ireland) Order 1981 to make legal aid available without payment of a contribution to those with disposable income of £2,860 a year or less (instead of £2,645).

The upper limit for disposable capital above which legal aid may be refused if it appears that the applicant could afford to proceed without legal aid remains at £6,310 or, in connection with proceedings involving a personal injury, £8,000.

The lower limit of disposable capital below which no contribution in respect of capital may be required, remains at £3,000.

Notice is hereby given that the Lord Chancellor, in exercise of the powers conferred on him by Articles 7(3), 22(1) and 27 of the Legal Aid, Advice and Assistance (Northern Ireland) Order 1981, has made a Statutory Rule entitled the Legal Advice and Assistance (Financial Conditions) Regulations (Northern Ireland) 1991.

These Regulations, which come into operation on 8th April, 1991, increase the lower income limit for legal advice and assistance under Part II of the Legal Aid, Advice and Assistance (Northern Ireland) Order 1981 to make legal advice and assistance available without payment of a contribution to those with disposable incomes of £70 a week or less (instead of £64).

The capital limit in relation to legal advice and assistance remains at £935. The capital limit in relation to assistance by way of representation remains at £3,000.

The Department of Agriculture, the Department of Economic Development, the Department of the Environment and the Department of Health and Social Services, being departments designated by the European Communities (Designation) Order 1983 for the purposes of section 2(2) of the European Communities Act 1972 in relation to measures relating to the prevention and limitation of the effects of accidents arising from industrial activities involving dangerous substances, acting jointly in exercise of the powers conferred on them by the said section 2(2) and acting jointly as the Department concerned in exercise of the powers conferred by Articles 17(1), (2) and 55(2) of, and paragraphs 1(1), (2), 14(1) and 19 of Schedule 3 to, the Health and Safety at Work (Northern Ireland) Order 1978 and of every other power enabling them in that behalf have made a statutory rule entitled the Control of Industrial Major Accident Hazards (Amendment) Regulations (Northern Ireland) 1991 (S.R. 1991 No. 141).

These Regulations amend the Control of Industrial Major Accident Hazards Regulations (Northern Ireland) 1985 ("the principal Regulations") for the purpose of implementing in full in respect of Northern Ireland, Council Directive No. 88/610/EEC (OJ No. L336, 7.12.88, p.14) ("the Directive") amending Council Directive No. 82/501/EEC (OJ No. L230, 5.8.82, p.1) on the major accident hazards of certain industrial activities which was implemented by the principal Regulations.

The definitions of "dangerous substance", "the Directive" and "Industrial activity" in the principal Regulations have been modified to take into account the changed structure and broadened scope of Schedule 2. New definitions of "further relevant information" and "preparation" have been included as these are necessary to give effect to the requirements of the Directive.

Regulations 4 and 6 of the principal Regulations are modified to take into account the changes to Schedule 2.

Regulation 12 of the principal Regulations which relates to information to the public has been replaced by regulation 8 of the amending Regulations as more information about an industrial activity is now required to be given to the public in accordance with Article 1.1 of, and Annex VII to, the Directive.

Schedule 1 to the principal Regulations is amended by adding the criterion for "oxidizing substances".

The amending Regulations replace Schedule 2 to the principal Regulations. The Schedule now applies to any storage that is either isolated storage or, with certain exceptions, to storage associated with an industrial installation. Part I of the Schedule contains an expanded list of named substances with threshold quantities for the application of the principal Regulations, and Part II introduces a list of categories of substances and preparations grouped into four entries with threshold quantities similarly specified.

Regulations 7, 11 and 12 of the amending Regulations make minor and consequential amendments to the principal Regulations and regulation 14 and Schedule 3 introduce new compliance dates and transitional provisions for industrial activities which become subject to certain provisions of the principal Regulations as a consequence of the amendments made by these Regulations.

The amending Regulations introduce as Schedule 7A to the principal Regulations, a new Schedule specifying the information about a site which must be supplied to the public under regulation 12 of the principal Regulations.
