1. Each consignment must be accompanied by:

- A certificate in accordance with the terms of Council Directive 64/433/EEC (as amended) signed by an official (a) veterinarian of the Government of the Federal Republic of Germany, which must be annotated in accordance with any European Commission Decision in force at the time of certification; and
- (b) A supplementary certificate signed by an official veterinarian of the Government of the Federal Republic of Germany stating either:

- The pigmeat or offal to which this licence refers must be transported to Northern Ireland in a sealed container and the container seal number quoted on the certificate. Where the meat is examined by Customs/Port Health Authorities while in transit the container must be resealed and the documents endorsed accordingly.
- 3. Twelve working hours notice of arrival in Northern Ireland of each consignment must be given to the Portal Supervisor at Magnet House, 81-93 York Street, Belfast, Telephone Belfast 324681 Ext. 2011 or 2012.
- 4. Consignments shall not be transhipped through any free port.
- 5. On arrival in Northern Ireland the certification in respect of the consignment must be presented to an Imports Inspector of the Department. The consignment must not be removed from the portal area until clearance has been given by the Inspector.
- 6. Any pigmeat or offal imported under this licence shall be made available for inspection by an Officer of the Department at premises nominated by him. The importer or his agent shall afford all assistance necessary to such an officer to enable him to carry out the inspection.

NOTE:

- Nothing in this licence gives exemption from any prohibition or restriction imposed by the Imported Food (Northern Ireland) Regulations 1984 or the Medicines Act 1968 and 1971 or by any regulations superseding or amending the same.
- 2. Any breach of any condition attached to this licence will constitute an offence against the Diseases of Animals (Northern Ireland) Order 1981.

## DEPARTMENT OF EDUCATION
