### **EUROPEAN COMMUNITIES ACT 1972**

Electrical Equipment for Explosive Atmospheres (Certification) (Amendment) Regulations (Northern Ireland) 1991 No. 339

The Department of Economic Development, as the Department concerned, has made Regulations under the European Communities Act 1972 entitled 'Electrical Equipment for Explosive Atmospheres (Certification) (Amendment) Regulations (Northern Ireland) 1991' (S.R. 1991 No. 339).

The Regulations amend regulation 2(1) of the Electrical Equipment for Explosive Atmospheres (Certification) Regulations 1990 (S.R. 1990 No. 284) to give effect to the provisions of Council Directive 90/487/EEC (O.J. No. L270, 2.10.90, p.23) concerning electrical equipment for use in potentially explosive atmospheres employing certain types of protection.

The effect of this amendment is to extend the list of harmonised standards defined in S.R. 1990 No. 284.
