### NORTHERN IRELAND COURT SERVICE

Notice is hereby given that the Lord Chancellor, in exercise of the powers conferred on him by Article 13 of the Magistrates' Courts (Northern Ireland) Order 1981 and sections 2A and 8 of the Backing of Warrants (Republic of Ireland) Act 1965 has made a Statutory Rule entitled the Magistrates' Courts (Backing of Warrants from the Republic of Ireland) (Amendment) Rules (Northern Ireland) 1992.

New rules 6A and 6B are inserted into the 1965 Rules to specify the periods during which an application to state a case must be made and within which the court must comply with such an application.
