BY THE LORD LIEUTENANT GENERAL AND GENERAL GOVERNOR OF IRELAND.

FITZALAN OF DEBWENT.

WHEREAS by the 24th section of The General Prisons (Ireland) Act, 1877, it is enacted that from and after the 1s⁴ day of April, 1878, a Visiting Committee shall at such time in each year, and in such manner as the Lord Lieutenant shall by Order from time to time prescribe, be appointed by the Grand Jury of every County for every Prison, the Board of Superintendence of which shall have been dissolved by the said Act, consisting of such number of persons being Justices of the Peace, as, having regard to the locality of such Prison and to the class of prisoners to be confined therein, may from time to time be determined by the Lord Lieutenant:

And WHEREAS by the Third section of the Prisons (Ireland) Amendment Act, 1884, it is enacted that where any Prison is not exclusively used for the confinement of prisoners belonging to any one County, a Joint Visiting Committee may, notwithstanding anything contained in section 24 of the General Prisons (Ireland) Act, 1877, be appointed for such Prison if the Lord Lieutenant so orders, and that a Joint Committee shall consist of so many Justices as the Lord Lieutenant shall prescribe who shall be appointed by such Grand Juries, and in such proportions as the Lord Lieutenant, having regard to the locality, and use of the Prison and the class of prisoners confined therein, may from time to time order: And WHEREAS it appears to the Lord Lieutenant expedient to make the Order following:

Now WE, The Right Hchourable Edmund Bernard Viscount Fitzalan of Derwent, Lord Lieutenant General and General Governor of Ireland, in pursuance of the powers conferred upon Us by the 24th section of the General Prisons (Ireland) Act, 1877, the Third section of the Prisons (Ireland) Amendment Act, 1884, the Government of Ireland Act, 1920, and the Orders made thereunder, and of every other power enabling Us in this behalf, and having regard to the locality and use of the Prisons set out in the Schedule to this Order, and the class of prisoners to be confined in such Prisons, Do Hereby Order and Direct as follows (that is to say):—

The Order of 22nd of June, 1904, relative to the appointment of Visiting Committees for Prisons in Ireland is hereby revoked so far as relates to the Prisons mentioned in the Schedule to this Order, provided that any appointment heretofore made under the said Order of 22nd of June, 1904, shall remain in force until the substituted provisions of this Order come into operation:

The Joint Visiting Committee of the several Prisons set out in the first column of the Schedule hereto shall be appointed by the several Grand Juries respectively specified in the second column of such Schedule, in respect of each such Prison, and such Committees shall consist of the number of Justices of the Peace specified in the third column of the same Schedule, and shall be appointed at the re-

<u>;;;;;</u> 509 spective times for appointment in each year specified in the fourth column of the same Schedule:

The Joint Visiting Committee of a Prison appointed at any such time shall continue to act until the specified time for appointment in the next succeeding year, provided always that if any Grand Jury hereby ordered to appoint such members of a Joint Committee shall make default in doing so at the time by this Order appointed for that purpose, the members of the Joint Visiting Committee appointed to represent the Grand Jury making such default as aforesaid shall continue to act until the members of a Joint Visiting Committee shall be appointed at a subsequent time for appointment.

NATIONAL HEALTH INSURANCE ACTS, 1911 to 1921.

MERCHANT SHIPPING (SHIPS' NAMES) AMENDMENT REGULATION, 1922.

REGULATION DATED 23RD JUNE, 1922, MADE BY THE BOARD OF TRADE, IN CONJUNCTION WITH THE COMMISSIONERS OF CUSTOMS AND EXCISE, UNDER SECTION 50 OF THE MERCHANT SFIPPING ACT, 1906 (6 Edw. 7, ch. 48).

Under the provisions of Section 50 of the Merchant Shipping Act, 1906 (6 Edw. 7, ch. 48) the Board of Trade, in conjunction with the Commissioners of Customs and Excise, hereby make the following Regulation.

(1) There shall be substituted for paragraph (a) of Regulation 6 of the Board of Trade Regulations dated 28th August, 1907 (Statutory Rules and Orders, 1907, No. 740) the following paragraph:—

"(a) If they are satisfied that the ship is intended to replace another of the same name which within 10 years of the date of the application belonged to the same owner when her British registry was closed, or which, within 10 years of the date of the application, was sold by the same owner on condition that her name should (be changed, and her name has been changed."

(2) This Regulation shall come into force on the 1st day of July, 1922, and may be cited as the Merchant Shipping (Ships' Names) Amendment Regulation, 1922, and shall be construed as one with those contained in Statutory Rules and Orders, 1907, No. 740, and those Regulations and this Regulation may be cited together as the Merchant Shipping (Ships' Names) Regulations, 1907 to 1922.

ORDER OF THE MINISTRY OF FINANCE AS TO THE COLLECTION BY STAMPS OF FEES PAYABLE TO THE REGISTRAR UNDER THE COMPANIES ACTS, 1908-1917.

WHEREAS in pursuance of the Government of Ireland Act, 1920, and the various Orders in Council made thereunder, the powers and duties exercised and performed by the Treasury in relation to the financial business of the United Kingdom were as regards Northern Ireland transferred to the Ministry of Finance tor Northern Ireland.

And Whereas in pursuance of the powers vested in the Treasury by Section 3 of the Public Offices Fees Act, 1879 (42 and 43 Vic., ch. 58), certain regulations were made by a Treasury Order dated 31st January, 1901, for the collection of fees payable to the Companies Registration Office.

And Whereas it is expedient to amend such regulations.

Now the Ministry of Finance for Northern Ireland hereby revokes the above-named Regulations in so far as they relate to the sole use of adhesive stamps for denoting fees payable to the Registrar of Joint Stock Companies for Northern Ireland on the issue of copies of registered documents to the public, and it is hereby directed that the said fees may be collected by means of such impressed stamps as shall from time to time be adopted by the Ministry.
