CONDITIONS ATTACHING TO THIS LICENCE

1. Each consignment must be accompanied by a certificate in accordance with the terms of the Council Directive 64/433/EEC (as amended) on health problems affecting intra-Community trade in fresh meat signed by an official veterinarian of the government of the exporting country and annotated in accordance with any European Commission Decision in force at the time of certification.
2. Any meat or offal to which this licence refers must be transported to Northern Ireland in a sealed container.
3. Any meat or offal imported under this licence shall be made available if so required for inspection by an officer of the Department. The importer or his agent shall afford all assistance necessary to such an officer to enable him to carry out the inspection.

NOTES:

Nothing in this licence gives exemption from any requirements of the Imported Food (Northern Ireland) Regulations 1991, the Medicines Act 1968 and 1971 or by any regulation superseding or amending the same.

Any breach of any condition of this licence will constitute an offence against the Diseases of Animals (Northern Ireland) Order 1981.

DEPARTMENT OF EDUCATION

Notice is hereby given that the Department of Education in exercise of the powers conferred on it by Articles of the Education and Libraries (Northern Ireland) Order 1972 and of all other powers enabling it in that behalf, has made a Statutory Rule entitled: The Education Reform (1989 Order) (Commencement No. 6) Order (Northern Ireland) 1992 (SR 1992 No. 507 (c.22)).

The purpose of this Rule is to bring into operation on 30th November, 1992

- (a) Article 9 of the Education Reform (Northern Ireland) Order 1989 which prohibits schools from providing courses of study for pupils of compulsory school age which lead to qualifica-

tions authenticated by a person other than a member of staff of the school, unless the qualification, and either the syllabus or syllabus criteria are approved by the Department; and

- (b) Article 11(1) (d) of the 1989 Order which requires Boards of Governors and Principals of grant-aided schools to ensure that Article 9 is not contravened.

It also brings into operation on 1st April, 1993, Article 56 of the 1989 Order which requires Education and Library Boards to make available a sum of money to Boards of Governors of special schools not covered by the scheme.

DEPARTMENT OF ECONOMIC DEVELOPMENT

Notice is hereby given that the Department of Economic Development has made a Statutory Rule entitled the Companies (1986 Order) (Accounts of Small and Medium-Sized Enterprises and Publication of Accounts in ECUs) Regulations (Northern Ireland) 1992 (S.R. 1990 No. 503) which comes into operation on 31st December, 1992.

These Regulations implement Council Directive 90/604/EEC (O.J. No. L 317, 16.11.1990, pages 57 to 59) which amends Directive 78/660/EEC on annual accounts (O.J. No. L 222, 14.8.1978, pages 11 to 31) (the Fourth E.C. Company Law Directive) and Directive 83/349/EEC on consolidated accounts (O.J. No. L 193, 18.7.1983, pages 1 to 17) (the Seventh E.C. Company Law Directive) as concerns the exemptions for small and medium-sized companies and the publication of accounts in ECUs. They also take advantage of some existing Member State options in Directive 78/660/EEC on annual accounts and make some minor amendments to Part VIII of the Companies (Northern Ireland) Order 1986 ("the 1986 Order" (Accounts and Audit)).

Regulation 2 permits delivery to the registrar of companies and publication of accounts translated into European Currency Units (ECUs).

Regulation 3 and the Schedule to the Regulations modify the requirements of Part VIII of the 1986 Order and Schedule 8 to that Order (exemptions for small and medium-sized companies) in respect of the content of the annual accounts and directors' reports of small companies. These exemptions apply not only to the individual accounts of such companies but also to the group accounts where a small company prepares them.

Regulations 4 and 5 raise the thresholds contained in Articles 255 and 257 of the 1986 Order for the exemptions applicable to small and medium-sized companies and groups.

Regulation 6 contains transitional provisions. Regulation 6(1) provides for the Regulations to apply to accounts for financial years ending on or after the date of coming into operation of the Regulations. Regulation 6(2) makes transitional provision to enable companies to take early advantage of the new thresholds for small and medium-sized companies.

The Regulations also correct two minor defects in the 1986 Order. Regulations 4(2) and 5(2) correct the position whereby certain small and medium-sized companies were technically precluded from filing abbreviated accounts with the registrar of

companies. Paragraph 4(3) of the Schedule to the Regulations restores the exemption for small companies from the requirement to disclose the auditors' remuneration in the abbreviated accounts they may deliver to the registrar of companies. This exemption was inadvertently removed by the Companies (Northern Ireland) Order 1990.

WEIGHTS AND MEASURES (NORTHERN IRELAND) ORDER 1981

The Department of Economic Development has made Regulations under the Weights and Measures (Northern Ireland) Order 1981 entitled the Weights and Measures (Testing and Adjustment Fees) Regulations (Northern Ireland) 1992 (SR 1992 No. 483).

The Regulations, which come into operation on 21st December, 1992, increase by between 2.5% and 7.5% all the fees previously charged under the Weights and Measures (Testing and Adjustment Fees) Regulations (Northern Ireland) 1991.

The Regulations, which come into operation on 1st January 1993, implement Council Directive 90/384/EEC on the harmonisation of the law of the member States relating to non-automatic weighing instruments in so far as they relate to instruments, in use for trade, covered by regulation 3 of the Non-automatic Weighing Instruments (EEC Requirements) Regulations 1992 S.I. 1992/1579. Instrument is defined in regulation 2 of these Regulations.

These Regulations make provision as to –

- (a) the purposes for which such instruments may be used for trade (regulation 4);
- (b) manner of erection of instruments (regulation 5);
- (c) instruments marked with a temperature range (regulation 6);

- (h) restrictions on the use of certain instruments used in association with weights (regulation 11);
- (i) restrictions on use of instruments where weight scale intervals are expressed solely in decimal parts of a pound (regulation 12); and
- (j) balance or zero setting of instrument before use (regulation 13).
