The Department, being of the opinion that certain parts of the above-mentioned roads are no longer necessary for road traffic, hereby gives notice of its intention to make orders under Article 40 of the Roads (Northern Ireland) Order the effect of which would be to abandon the following:

- (i) an area of footway of approximately 4.5 square metres on the northern side of Alexander House, Victoria Parade;
- (ii) a length of approximately 37 metres of footway extending alongside the western (part) and northern sides of Dill House and beyond in Queens Parade;
- (iii) areas of road totalling approximately 780 square metres in Kildare Place; and
- (iv) areas of footway totalling approximately 18 square metres and an area of approximately 32 square metres of carriage-way in City Way

all in the City of Belfast.

The areas and lengths of road proposed to be abandoned are delineated on maps which, together with copies of the appropriate draft orders, may be inspected free of charge at all reasonable hours during the period from 11th December, 1992 to 18th January, 1993 at the Department's Roads Service Headquarters, Room 214, Commonwealth House, 35 Castle Street, Belfast BT1 1GU; at the Department's Divisional Roads Service, Belfast Division, Hydebank, 4 Hospital Road, Belfast; and at the Department's Belfast Development Office Clarendon House, 9-21 Adelaide Street, Belfast.

Any person may within the said period object to the proposal by written notice to Roads Service Headquarters at the address above stating the grounds of objection.
