EMPLOYMENT OF WOMEN, YOUNG PERSONS AND CHILDREN ACT, 1920.

The Ministry of Labour for Northern Ireland gives notice that in pursuance of the Employment of Women, Young Persons and Children Act, 1920, and of the Government of Ireland Act, 1920, and the several Orders made thereunder, it has made an Order authorising the employment of Packing, Spinning, Laying, Baling, Clipping and Packing of Trawl Twine on two day-shifts of women and young persons of 16 years of age and over, at the factory of the Belfast Ropework Company, Limited, Belfast.

NATIONAL HEALTH INSURANCE ACTS (NORTHERN IRELAND), 1924-1931.

THE CONTRIBUTORY PENSIONS (PATIENTS OF UNSOUND MIND) REGULATIONS (NORTHERN IRELAND), 1931.

The Ministry of Labour for Northern Ireland hereby gives notice that Regulations have been made under the Widows', Orphans' and Old Age Contributory Pensions Acts (Northern Ireland), 1925-1931, prescribing the amount up to which pensions accruing to patients of unsound mind detained in public mental hospitals may be paid by the Ministry of Labour to the Local Authorities concerned for the purpose of providing additional comforts for them.
