#### **ROAD TRAFFIC AND VEHICLES**

EXPERIMENTAL SPEED LIMIT (ROUTE A1) (No. 3)
ORDER (NORTHERN IRELAND) 1995

Made

16th October 1995

Coming into operation

7th December 1995

Whereas the Experimental Speed Limit (Route AI) Order (Northern Ireland) 1995(a) prohibits the driving of motor vehicles at a speed greater than 60 miles per hour on the lengths of road specified in the Schedule for a period of 4 months from 7th April, 1995:

And Whereas the Experimental Speed Limit (Route A1) (No. 2) Order (Northern Ireland) 1995(b) continues in force the said prohibition for a period of 4 months from 7th August, 1995;

And Whereas the Department of the Environment is satisfied that it is desirable in the interests of safety to continue to restrict the speed of motor vehicles on those lengths of road;

Now Therefore the Department, in exercise of the powers conferred on it by Article 51(4) of the Road Traffic (Northern Ireland) Order 1981(c) and of every other power enabling it in that behalf, makes the following Order:

#### Citation and commencement

1. This Order may be cited as the Experimental Speed Limit (Route Al) (No. 3) Order (Northern Ireland) 1995 and shall come into operation on 7th December, 1995.

Continuance in force of provisions of S.R. 1995 No. 66

- The provisions of Article 2 of the Experimental Speed Limit (Route A1) Order (Northern Ireland) 1995 are hereby continued in force for a period of 4 months from 6th December, 1995.

- The northbound carriageway of Route A1, from a point approximately 675 metres south-west of its junction with Newry Road, Route A26, Banbridge, to a point approximately 222 metres north of its junction with Dromore Road, Route A26, Banbridge.
- The southbound carriageway of Route AI, from a point approximately 210 metres north-east of its junction with Waringsford Road, Banbridge, to a point approximately 485 metres south-west of its junction with Cascum Road, Banbridge.
- The northbound carriageway of Route AI, from a point approximately 660 metres south-west of its junction with Rowantree Road, Dromore, to a point approximately 674 metres east of its junction with Milebrush Road, Unclassified No. 4022, Dromore.

 The southbound carriageway of Route A1, from a point approximately 350 metres north of its junction with Grove Road, Dromore, to a point approximately 304 metres southwest of its junction with Banbridge Road, Route B2, Dromore.

#### **EXPLANATORY NOTE**

#### (This note is not part of the Order.)

The Experimental Speed Limit (Route Al) (No. 2) Order (Northern Ireland) 1995 (S.R. 1995 No. 268) continues in force the provisions of the Experimental Speed Limit (Route Al) Order (Northern Ireland) 1995 (S.R. 1995 No. 66).

This Order further continues in force those provisions. It prohibits in the interests of safety for a further period of 4 months commencing on 7th December, 1995, the driving of motor vehicles at a speed greater than 60 miles per hour on the sections of Route A1 described in the Schedule.

Any person who acts in contravention of the Order shall be guilty of an offence under the Road Traffic (Northern Ireland) Order 1981 and shall be liable on summary conviction to a fine not exceeding level 3 on the standard scale (£1,000).

Traffic signs indicating the effect of the Order have been erected on the road.

#### **URBAN CLEARWAYS, BELFAST**

Notice is hereby given that the Department of the Environment in exercise of the powers conferred on it by Article 21(1) of the Road Traffic (Northern Ireland) Order 1981 and of all other enabling powers made on 11th October, 1995 an Order entitled Urban Clearways (Belfast) (No. 2) Order (Amendment No. 3) Order (Northern Ireland) 1995 (SR 1995 No. 390) which will come into operation on 27th November 1995.
