### NORTHERN IRELAND COURT SERVICE

Notice is hereby given that the Lord Chancellor, in exercise of the powers conferred upon him by Article 13 of the Magistrates' Courts (Northern Ireland) Order 1981 and of all other powers enabling him in that behalf, on the advice of the Magistrates' Courts Rules Committee and after consultation with the Lord Chief Justice, has made a Statutory Rule entitled: The Magistrates' Courts (Children's Evidence) (Notices of Transfer) Rules (Northern Ireland) 1996.

These Rules, which come into operation on 8th April 1996, provide for the procedure to be followed in magistrates' courts where a notice of transfer is given under Article 4(1) of the Children's Evidence (Northern Ireland) Order 1995 which comes into operation on 8th April 1996.

Rule 3 provides that where a magistrates' court has ordered that a person, to whom a notice of transfer relates, be kept in custody, a warrant of commitment (in Form 1) shall be issued.

Rule 4 provides that where a recognizance is enlarged in a surety's absence the clerk of petty sessions shall inform the surety of the court's decision.

Rule 5 provides for certain documents to be sent to the Crown Court by the magistrates' court to which a notice of transfer has been given.

Rule 3 revokes Rules 25A and 31(2)(a) of the principal Rules and makes transitional arrangements.

Rule 4 inserts a new Rule 149A into the principal Rules which replaces Rule 25A and reflects the amendments made to Article 81 of the 1989 Order by the Children's Evidence (Northern Ireland) Order 1995. Rule 149A provides for applications for the leave of the court under Article 81(2) of the 1989 Order (evidence through television link by witness who will not give evidence otherwise through fear or who is a child or who is to be cross-examined after admission of video recording of testimony).

Rule 6 inserts two new Rules, Rules 10A and 10B into the 1969 Rules. Rule 10A provides that Rule 149A of the principal Rules shall apply to applications to juvenile courts for leave under Article 81(2) of the 1989 Order.

Rule 10B provides for applications to juvenile courts for leave under Article 81A of the 1989 Order (video recordings of testimony from child witnesses).
