# PROPOSAL FOR A DRAFT RATES (AMENDMENT) ORDER

The Department of Finance and Personnel has published a Proposal for a draft Order in Council entitled The Rates (Amendment) (Northern Ireland) Order 1996. The draft Order will amend the principal legislation, The Rates (Northern Ireland) Order 1977 (1977 No. 2157 (N.I.28)) by making provisions for:

- (a) different rate poundages to be fixed in respect of different classes of property;
- (b) the date of rate liability in respect of newly erected property;
- (c) the power to introduce transitional rate relief;
- (d) the power to amalgamate separate properties and separate single properties for valuation purposes;
- (e) the power to revise the rating of properties used for water and sewerage purposes;
- (f) industrial property not to include any part used as a private dwelling;
- (g) a dwelling house not to include any part used for occupation on a commercial basis;
- (h) rate exemption for property used in association with salmon or eel fishings or as public parks;
- the power to determine a decapitalisation rate for certain property valued on the "contractors basis"; and
- the power to revise the rating of property used for plant and machinery and railways.

Coppies Flood Alleviation Scheme, Magherafelt

The Department of Agriculture for Northern Ireland hereby gives Notice in pursuance of Article 12 (as amended) of the Drainage (Northern Ireland) Order 1973 that it proposes to carry out a drainage scheme on the Coppies River, the Coppies minor watercourse MW 1902, part of the Coppies Extension MW 1902 Ext and part of the Ballymoghan Drain MW 1912. These watercourse drain the land between Magherafelt and the Moyola River.

The scheme involves work to the river channel and bridges between its confluence with the Moyola and a point approximately 400 metres upstream of Station Road, Magherafelt.

Having determined that the proposed works are not, by reason amongst other things of their nature, size or location, likely to have significant environmental effects it is the Department's intention not to prepare an Environmental Statement.




# PUBLIC LOCAL INQUIRY
