TREASURY

VALUE ADDED TAX

Treasury Direction dated 22 April 1996 under section 41(3) of the Value Added Tax Act 1994 as to the refund to Government departments of tax charged on the supply of goods or services or on the acquisition or importation of goods by them otherwise than for the purpose of any business carried on by them or on a supply of goods or services by them treated as a supply in the course or furtherance of a business.

The Treasury, in exercise of the powers conferred on them by section 41(3) of the Value Added Tax Act 1994 (1994 c.23), hereby direct as follows:

- 1. This direction shall come into operation on 26 April 1996.
- 2. Subject as provided in paragraph 3, a Government department listed in or belonging to a category of departments listed in List 1 of this direction may claim and be paid a refund of the tax charged on -
 - (a) the supply to it of any services of a description in List 2;
 - (b) the supply to it of leased accommodation for more than 21 years as part of the supply to it of any services of a description in List 2; or
 - (c) the supply to it or acquisition from another member State or importation from outside the member States by it of goods closely related to the supply to it of any services of a description in List 2.
- 3. A tax refund as described in paragraph 2 will only be paid if -
 - (a) either the supply of those services or goods is not for the
 - (i) any business carried on by the department: or
 - (ii) any supply by the department which, by virtue of directions made under section 41(2) and (5) of the Value Added Tax Act 1994, is treated as a supply in the course or furtherance of a business; and
 - (b) the department complies with the requirements of the Commissioners of Customs and Excise both as to the time, form and manner of making the claim and also on the keeping, preservation and production of records relating to the supply, acquisition or importation in question.

4. The Treasury Direction dated 2 March 1995 is hereby revoked.

1. The Director General of Telecommunications (the "Director") in accordance with section 12 (2) of the Telecommunications Act 1984 (the "Act") hereby gives notice that he proposes to make modifications to the licences granted to

- 2. The principal modification which the Director proposes to make is the substitution of a new Condition "Public Call Box Services" for the existing provision (appearing as Condition 16, 17, 21 or 26, as the case may be, in the Licences). The effect of the proposed modification is to
 - remove the existing requirement for the Director to determine that there is a reasonable demand for call box services before such services may be provided at any given location;
- (ii) remove the requirement for the Licensee to install public call boxes in accordance with published guidelines approved by the Director and to provide or permit the provision of call box services at such boxes and instead to impose an obligation on the Licensee to maintain the provision of such services at any public call box at which it provides them or permits them to be provided until such services cease to be provided in accordance with the new Condition;
- (iii) require the display of a notice in public call boxes specifying the minimum charge for calls, the means by which the charge may be paid, the rate applicable, the location of the public call box for emergency purposes, that the Licensee or other person referred to in the notice will deal with complaints, that emergency calls are free and whether incoming calls are available.
- (iv) remove the current detailed restriction governing the circumstances in which the Licensee is entitled to cease providing call box services at a public call box, including in certain cases the obligation to obtain the agreement of the Director to such cessation and instead to entitle the Licensee to cease to provide or to secure the provision of such services if it has displayed in the call box a notice in accordance with the new Condition and the period mentioned in the notice (which must not be less than 42 days) has expired;
- (v) remove the requirement that prepayment apparatus installed in public call boxes is approved under the Act.

The requirement for the Licensee to provide telephones capable of being used in conjunction with hearing aids will remain. The Director also proposes to make a number of modifications consequential on the principal modification mentioned above.

- 3. The Director proposes to make the modifications described above because having been charged with keeping the provision of public call box services under review he has concluded that these detailed restrictions are inhibiting the development of the public payphone market. The purpose of the modifications is therefore to deregulate the position as far as possible consistent with the needs of users. This is also a convenient opportunity to transfer the requirement to display consumer information on public payphones from the approval regime under Section 22 of the Act to a licence obligation. These changes will not affect the obligations of BT and Kingston Communications whose licences carry universal service obligations requiring them to maintain reasonable access to public call boxes and imposing strict rules governing the cessation of public call box services at individual boxes. Nor will the changes affect the existing requirements of planning law as applicable to the siting etc of public call boxes.
- 4. The Director is required by section 12 (2) of the Act to consider any representations or objections which are duly made and not withdrawn. Following such consideration and the consent of the Licensees to the modifications, the Director proposes to make the modifications forthwith.
- 5.
