NORTHERN IRELAND OFFICE

The Northern Ireland Office has published a Proposal for a draft Order in Council entitled the Criminal Justice (Children) (Northern Ireland) Order. Copies may be purchased from The Stationery Office Bookshop, 16 Arthur Street, Belfast BT1 4GD.

This Order will introduce a number of changes to the juvenile justice system. It will include measures to:

- bring 17-year-olds within the juvenile system;
- require courts, when dealing with children, to have regard to the prejudicial effect on the child's welfare of any delay;
- require courts to release children on bail except where the seriousness of the offence and the need to protect the public from serious harm mean that a custodial remand is necessary;
- where the juvenile court is hearing criminal proceedings, rename it the youth court;
- replace the training school order with the juvenile offenders centre order – a mixed custody/supervision order for a determinate period;
- abolish the supervision order (in justice cases) and committal to the care of a fit person;
- rename the Rathgael and Whiteabbey Schools Management Board as the Juvenile Justice Board, and provide for its powers to be varied as appropriate.

THE REGISTERED RENTS (INCREASE) ORDER (NORTHERN IRELAND) 1997

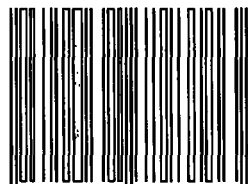
