THE KING'S MOST EXCELLENT MAJESTY IN COUNCIL.

WHEREAS by Part II of the Administration of Justice Act, 1920, provision has been made for the reciprocal enforcement of judgments in the United Kingdom and in other parts of His Majesty's Dominions:

And Whereas by the said Act it is, amongst other things, provided that where His Majesty is satisfied that reciprocal provisions have been made by the Legislature of any part of His Majesty's Dominions outside the United Kingdom for the enforcement within that part of His Dominions of judgments obtained in the High Court in England, the Court of Session in Scotland, and the High Court in Ireland, His Majesty may by Order in Council declare that the said part of that Act shall extend to that part of His Dominions, and that on any such Order being made the said part of that Act shall extend accordingly:

And Whereas on the 6th day of December, 1922, the Irish Free State was established under the provisions of an Act of Parliament shortly entitled the Irish Free State Constitution Act, 1922 (Session 2):

And Whereas His Majesty is satisfied that the Legislature of the part of His Majesty's Dominions outside the United Kingdom hereinafter mentioned has made reciprocal provisions for the enforcement within that part of judgments obtained in the High Court in England, the Court of Session in Scotland, and the High Court in Ireland:

Now, Therefore, His Majesty, by virtue and in exercise of the powers by the above-recited Act in His Majesty vested, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

1. Part II of the Administration of Justice Act, 1920, shall extend to the part of His Majesty's Dominions outside the United Kingdom hereunder mentioned:—

TASMANIA.

2. Nothing in this Order shall affect the registration or enforcement in the Irish Free State of any judgment in pursuance of Part II of the said Act.

WILD BIRDS PROTECTION ACT (NORTHERN IRELAND), 1931.

WHEREAS under Section 5 of the Wild Birds Protection Act (Northern Ireland), 1931, I, The Right Honourable Sir Richard Dawson Bates, Minister of Home Affairs, may by Order alter the classification of any bird from one category under said Act to another:

And Whereas representations have been made to me that the classification for geese (all species save barnacle and brent) should be varied by transferring them from Category 3 to Category 2:

And Whereas Notice was duly given by me on the 15th day of April, 1932, in accordance with the provisions of Section 16 (6) of the Wild Birds Protection Act (Northern Ireland), 1931, of my intention to make such an Order and the purport thereof, and no objections were received:

Now, Therefore, I, The Right Honourable Sir Richard Dawson Bates, hereby Order and Direct that geese (all species save barnacle and brent) shall from the date hereof be transferred from Category 3 to Category 2.

In accordance with the provisions of Section 2, Sub-Section (4) of the Merchandise Marks Act, 1926, the Board of Trade give notice that in pursuance of an application received by them for the making of an Order in Council to require imported wood wool and wood wool rope to bear an indication of origin, they have made a reference to the Standing Committee appointed by them under the Act in respect thereof.
