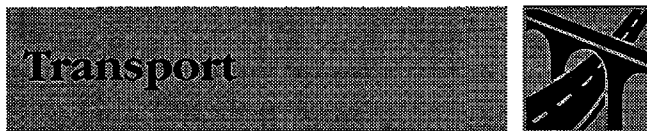

### Department of the Environment

The Department of the Environment has made a Statutory Rule under Article 3 of the Road Races (Northern Ireland) Order 1986 entitled the Road Races (Carrickfergus Kart Race) Order (Northern Ireland) 1999 (S.R. 1999 No. 319).

This Order permits the Ulster Karting Club Ltd as promoter of the Carrickfergus Kart Race to use for that event the roads named in the Order by suspending the right of way of other traffic between 6.00 pm and 10.00 pm on the 27th July, 1999.

In effect this Order temporarily closes those roads.

The Department of the Environment has made a Statutory Rule under Article 3 of the Road Races (Northern Ireland) Order 1986 entitled the Road Races (Ulster Grand Prix) Order (Northern Ireland) 1999 (S.R. 1999 No. 318).

This Order permits the Coleraine & District Motor Club Ltd as promoter of the Ulster Grand Prix to use for that event the roads named in the Order by suspending the right of way of other traffic between 10.00 am and 6.30 pm on the 21st August, 1999 and for practices therefor on the 18th and 19th August, 1999 from 12.30 pm to 5.30 pm.

In effect this Order temporarily closes those roads.

### ROADS Service

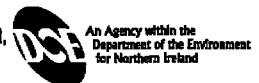
Notice is given that the Department of the Environment made -

on 19th July 1999 the Urban Clearways (Amendment No. 2) Order (Northern Ireland) 1999 (S.R. 1999 No. 329) which will come into operation on 9th August 1999. The effect of the Order is to prohibit vehicles from waiting in part of the north-west side of Bridge Street, Newry during the times 8.15a.m.-9.30a.m. on the days Monday to Friday inclusive;

on 19th July 1999 the Parking Places on Roads (Amendment No. 3) Order (Northern Ireland) 1999 (S.R. 1999 No. 330), which will come into operation on 16th August 1999. The Order authorises the introduction of parking places on the parts of the roads in Ballygowan, Ballymena, Banbridge, Bangor, Belfast, Blackwatertown, Carrickmore, Castlewells, Coleraine, Craigavon, Derrygonnelly, Downpatrick, Gilford, Killyleagh, Lenaderg, Lurgan, Newry, Newtownards, Portadown, Rathfriland, Richhill, Seapatrick, Tandragee and Warrenpoint specified in Schedule 1. These parking places will be for disabled persons' vehicles only. The Order also authorises the removal of the parking places in Belfast, Coleraine, Downpatrick and Newcastle specified in Schedule 2;

and on 20th July 1999 the Control of Traffic (Carrickfergus) Order (Northern Ireland) 1999 (S.R. 1999 No. 332) which will come into operation on 2nd August 1999. The Order prohibits vehicles travelling in a northerly direction along Chilton Road from making a right-hand turn into Windermere Road; in an easterly direction along Windermere Road, from making a right-hand turn into Chilton Road; and in a westerly direction along Windermere Road, from making a left-hand turn into Chilton Road.

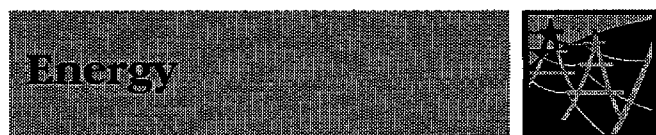
