ULSTER 3½% STOCK.

WHEREAS by Section 29 of the Petty Sessions Clerk (Ireland) Act, 1858, the Lord Lieutenant of Ireland was authorised to make such general rules as should seem to him expedient for the purpose of carrying into effect the provisions of the said Act and from time to time to amend and vary such rules:

And Whereas by virtue of the provisions of the Government of Ireland Act, 1920, and the Free State (Consequential Provisions) Act, 1922, the power of making and varying such rules is now vested in the Governor of Northern Ireland:

And Whereas on the 8th day of December, 1926, the Governor of Northern Ireland made certain rules fixing the limits of age or candidates for the position of Petty Sessions Clerk in Northern Ireland:

And Whereas it is expedient to vary the said rules made the 8th day of December, 1926:

Now I, James Albert Edward, Duke of Abercorn, K.G., K.P., Governor of Northern Ireland, in pursuance of the powers vested in me by the above Acts and all other powers me thereunto enabling, do hereby revoke the said rules made on the 8th day of December, 1926, and in substitution thereof do make the following Rules:—

From the date of this Order the limits of age of candidates seeking the appointment of Petty Sessions Clerk in Northern Ireland shall be 25 to 50 years, except in the following cases, that is to say:—

(a) In the case of a candidate who is already a Petty Sessions Clerk, the limits of age shall be 25 to 57 years.

- (b) In the case of any candidate who is serving or has served in the Royal Irish Constabulary or the Royal Ulster Constabulary, his services therein having been satisfactory, the limits of age shall be 25 to 57 years.
- (c) In the case of a female candidate, the limits of age shall be 25 to 40 years.

cisable in respect of any districts whether they are all situate in the same county or not, and it is thereby further provided that the appointment of a person to be the Clerk of such two or more Districts shall, on the first occasion for such appointment, in pursuance of the Order, be made by the Governor of Northern Ireland, who shall select for appointment some one of the persons who filled the office of Petty Sessions Clerk in any of those districts immediately before the coming into force of the Order, or, in the case of the unfitness of all such persons, then some other proper and fit person, and that the salary to be paid to the Clerk so appointed on the first occasion aforesaid for two or more districts shall notwithstanding anything in Section 6 of the Petty Sessions Clerk (Ireland) Act, 1858, be such as the Governor of Northern Ireland in his discretion may fix:

Now, I, James Albert Edward, Duke of Abercorn, K.G., K.P., Governor of Northern Ireland, in pursuance of the powers conferred upon me by the above-mentioned Acts and all other powers me thereunto enabling, do hereby order and declare that the Petty Sessions Districts of Lisnaskea and Derrylin, in the County of Fermanagh, shall from the 20th day of July, 1933, be served by one and the same person as Clerk:

And I do further appoint William Agnew, at present Clerk of the Petty Sessions for the District of Lisnaskea, to be Clerk of the Districts of Lisnaskea and Derrylin:

And I do further fix the salary of the said William Agnew as Clerk of the aforesaid Districts of Lisnaskea and Derrylin at the annual sum of One Hundred and Thirtyseven pounds.

MERCHANDISE MARKS ACT, 1926.
REFERENCE TO THE STANDING
COMMITTEE.

BRIAR PIPES AND BRIAR BOWLS.

In accordance with the provisions of Sub-Section (4) of Section 2 of the Merchandise Marks Act, 1926, the Board of Trade give notice that in pursuance of an application received by them for the making of an Order-in-Council to require imported goods of certain classes and descriptions to bear an indication of origin, they have made a reference to the Standing Committee appointed by them under the Act in respect of the following classes and descriptions of imported goods:—

- 1. Briar pipes, stained or unstained.
- 2. Briar bowls, stained or unstained.

As regards 1, attention is called to the fact that the Merchandise Marks (Imported Goods) No. 4 Order, 1928, requires imported briar tobacco pipes, whether stained or not, to bear an indication of origin at the time of sale or exposure for sale, except exposure for sale wholesale by a person being a wholesale dealer, and the Committee have

been asked to report upon the question whether a further Order-in-Council should be made in regard to these goods.

As regards 2, attention is called to the fact that, while under the provisions of the above Act, the Committee must in every case referred to them consider whether the goods should bear an indication of origin at the time of sale or exposure for sale, they may also at their discretion consider and report upon the question whether such goods should bear an indication of origin at the time of importation.
