The following Letters Patent were signed by Her Majesty The Queen on 2nd August 2000, in respect of the Education and Training (Scotland) Act 2000.

ELIZABETH THE SECOND by the Grace of God of the United Kingdom of Great Britain and Northern Ireland and of Our other Realms and Territories Queen Head of the Commonwealth Defender of the Faith To Our trusty and well beloved the members of the Scottish Parliament GREETING:

FORASMUCH as a Bill has been passed by the Scottish Parliament and has been submitted to Us for Our Royal Assent by the Presiding Officer of the Scottish Parliament in accordance with the Scotland Act 1998 the short Title of which Bill is set forth in the Schedule hereto but that Bill by virtue of the Scotland Act 1998 does not become an Act of the Scottish Parliament nor have effect in the Law Without Our Royal Assent signified by Letters Patent under Our Scottish Seal (that is Our Seal appointed by the Treaty of Union to be kept and used in Scotland in place of the Great Seal of Scotland) signed with Our Own hand and recorded in the Register of the Great Seal We have therefore caused these Our Letters Patent to be made and have signed them and by them do give Our Royal Assent to that Bill COMMANDING ALSO the Keeper of Our Scottish Seal to seal these Our Letters with that Seal.



Notice Of Determination By The Department For Regional Development Under Article 67a Of The Roads (Northern Ireland) Order 1993

Grade Separated Junction At A1 Banbridge Bypass And B10 Rathfriland Road, Banbridge

The Department for Regional Development hereby gives notice in accordance with Article 67A (1) and (9) of the Roads (Northern Ireland) Order 1993 that it considers that its proposal to realign the B10 Rathfriland Road, Banbridge to create a through route is a relevant project within the meaning of Article 67 (1) of the Roads (Northern Ireland) Order 1993 and falls within Annex II of Council Directive 85/337/EEC as amended by Directive 97/11/EC.

The Department has determined after having regard to the selection criteria contained in Annex III of the Directive that this proposal should be made subject to an environmental impact assessment in accordance with the Directive.

A Notice of Determination was previously published during weeks ending 28th July and 4th August 2000.

Grade Separated Junction At A1 Banbridge Bypass And B10 Rathfriland Road, Banbridge in The Townlands Of Tullyear And Ballydown County Of Down

The Department for Regional Development hereby gives notice in accordance with Article 67A (3) and (9) of the Roads (Northern Ireland) Order 1993 that it has prepared an Environmental Statement on the effects of the proposed Grade Separated Junction at A1 Banbridge Bypass and B10 Rathfriland Road, Banbridge.

The general effect of the project will be to realign the B10 Rathfriland Road as a through route by the construction of new carriageway from the C0348, Ballydown Road for a length of 1 kilometre towards Banbridge incorporating a bridge over the A1 Banbridge Bypass and new link roads connecting the existing A1 junctions to the realigned B10 Rathfriland Road, Banbridge.

The proposed new length of road will consist of a 7.3 metre wide single carriageway and 3.5 metre wide verges which will incorporate a footway on the eastern side.

In addition to the earthworks and drainage, landscaping and other mitigation measures will be carried out to improve the appearance of the route and lessen the visual impact of the project.

The principal objective of the project is to improve road safety at the junction of the A1 Banbridge Bypass and the B10 Rathfriland Road.




