NATIONAL HEALTH INSURANCE ACTS, 1911 to 1922.

NOTICE is hereby given under the Rules Publication Act, 1893, that it is proposed by the National Health Insurance Joint Committee, after the expiration of at least 40 days from this date, in pursuance of the powers conferred upon them by Section 15 (2) of the National Health Insurance Act, 1920, and by the National Health Insurance Joint Committee (No. 2) Regulations, 1920, to make

Regulations providing that where members of an Approved Society who are resident in a particular part of the United Kingdom are, for the purposes of the National Health Insurance Act, 1911, relating to valuations, surpluses, deficiencies, and transfers, treated as if they formed a separate society, a member of the Society shall not be, and shall be deemed not to have been, disqualified from receiving additional benefits by reason only of his having changed his residence after 5th July, 1920, from one part of the United Kingdom to another.

THE MINISTRY OF HOME AFFAIRS FOR NORTHERN IRELAND.

To the several Local Authorities and their Officers in Northern Ireland; and to all others whom it may concern.

WHEREAS by sub-section (2) of Section 5 of the Local Government Act (Northern Ireland), 1922, (hereinafter referred to as "the Act"), it is enacted in effect as follows:—

"Every Officer holding an office of profit under or in the gift of a local authority or committee or joint-committee wholly or partly appointed by that Authority shall make and subscribe the Declaration of Allegiance prescribed in Part III. of the Schedule to the Act.

- (a) in the case of an officer holding office at the date of the passing of the Act within one month after that date;
 or
- (b) in the case of an officer appointed after the passing of the Act, within one month after his appointment.

No officer appointed after the passing of the Act shall enter upon the duties of his office until he has made and subscribed the said Declaration of Allegiance, and if any officer fails to make and subscribe the declaration within the said month his appointment shall be void and of no effect."

And Whereas by sub-section (1) of Section 8 of the Act it is enacted as follows:—

"The expression "Local Authority" means the Council of any County, borough, urban or rural district, a Board of Guardians and the Commissioners of any town.

And whereas by sub-section (1) of Section 7 of the Act it is provided that the Ministry of Home Affairs for Northern Ireland may make such Orders as appear to it to be necessary or proper for giving full effect to the Act:

Now, therefore, the Ministry of Home Affairs for Northern Ireland in exercise of all powers in that behalf enabling the Ministry hereby orders and directs as follows, that is to say:—

- (1) Every officer holding an office of profit under or in the gift of a local authority or committee or joint-committee wholly or partly appointed by that authority may make and subscribe the Declaration of Allegiance prescribed in Part III. of the Act before a Justice of the Peace or Commissioner to Administer Oaths, or where the Secretary or Clerk of a local authority has made the Declaration of Allegiance in the said manner, the Declaration of Allegiance of other officers of the same local authority may be made and subscribed before such Secretary or Clerk.
- (2) The Declaration of Allegiance shall be made and subscribed in duplicate, and a duplicate copy shall be transmitted to the Ministry

of Home Affairs for Northern Ireland at Belfast within seven days after it has been duly made and subscribed.
