



# Slaughter Premium Regulations (Northern Ireland) 2001. S.R. 2001 No. 199

(c) for the definition of "public appointment" there shall be substituted the following definition -

""public appointment" means any appointment, not being an extension of an existing appointment by re-appointment or otherwise, made by a department to a public body listed in Schedule 2 to the Commissioner for Complaints (Northern Ireland) Order 1996 (d), or in Part I of the Schedule to this Order, but excluding any public body listed in Part II of the Schedule to this Order.'


