ALTERING THE PROCLAMATION OF THE 4th OCTOBER 1953 DETERMINING NEW INSCRIPTIONS FOR GOLD, SILVER, CUPRO NICKEL, MIXED METAL AND BRONZE COINS

ELIZABETH R.

Whereas under section 3(1)(b) and (h) of the Coinage Act 1971 We have the power, with the advice of Our Privy Council, by Proclamation to determine the design of any coin to be made at Our Mint and to alter any Proclamation previously made under the said section:

And Whereas by Our Proclamation dated the 4th day of October 1953 We determined a new design for the gold coins specified in Our said Proclamation, being the five-pound piece, the two-pound piece, the sovereign and the half-sovereign:

And Whereas by Our Proclamation dated the 17th day of April 1985 We altered the paragraph headed "GOLD COINS" of Our said

Proclamation of the 4th day of October 1953 to determine a new design for the said gold coins:

And Whereas by Our Proclamation dated the 21st day of December 1988 We further altered the paragraph headed "GOLD COINS" of Our said Proclamation of the 4th day of October 1953 to determine a new design for the said gold coins:

And Whereas it appears to Us desirable to determine a new design for the said gold coins:

We, therefore, in pursuance of the said section 3(1)(b) and (h) and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:-

1. The following paragraph shall be substituted for the paragraph headed "GOLD COINS" of Our said Proclamation of 4th day of October 1953:-

"GOLD COINS

- (1) Five-Pound Piece – Every five-pound piece shall have either
- for the obverse impression Our effigy with the inscription "ELIZABETH.II.DEI.GRA REGINA.FID. DEF" and for the reverse the image of Saint George armed, sitting on horseback, attacking the dragon with a sword, and a broken spear upon the ground, and the date of the year, or
 - for the obverse impression Our effigy with the inscription "ELIZABETH.II.DEI.GRA REGINA.FID.DEF" and for the reverse the Shield of Arms of Our United Kingdom of Great Britain and Northern Ireland within an open wreath of laurel and ensigned by Our Royal Crown and beneath the whole the date of the year.
- The coins shall have a graining upon the edge.
- (2) Two-Pound Piece – Every two-pound piece shall have the same obverse and reverse impression and inscription in all respects as the five-pound piece described in either paragraph (1)(a) or (1)(b) above
- The coins shall have a graining upon the edge.
- (3) Sovereign – Every sovereign shall have the same obverse and reverse impression and inscription in all respects as the five-pound piece described in either paragraph (1)(a) or (1)(b) above
- The coins shall have a graining upon the edge.
- (4) Half-sovereign – Every half-sovereign shall have the same obverse and reverse impression and inscription in all respects as the five-pound piece described in either paragraph (1)(a) or (1)(b) above
- The coins shall have a graining upon the edge.

2. This Proclamation shall come into force on the twelfth day of December Two thousand and one.

Given at Our Court at Buckingham Palace, this eleventh day of December in the year of our Lord Two thousand and one and in the fiftieth year of Our Reign.

The Scottish Parliament (Letters Patent and Proclamations) Order 1999

FORASMUCH as a Bill has been passed by the Scottish Parliament and has been submitted to Us for Our Royal Assent by the Presiding Officer of the Scottish Parliament in accordance with the Scotland Act 1998 the short Title of which Bill is set forth in the Schedule hereto but that Bill by virtue of the Scotland Act 1998 does not become an Act of the Scottish Parliament nor have effect in the Law without Our Royal Assent signified by Letters Patent under our Scottish Seal (that is Our Seal appointed by the Treaty of Union to be kept and used in Scotland in place of the Great Seal of Scotland) signed with Our own hand and

recorded in the Register of the Great Seal We have therefore caused these Our Letters Patent to be made and have signed them and by them do give Our Royal Assent to that Bill COMMANDING ALSO the Keeper of Our Scottish Seal to seal these Our Letters with that Seal. IN WITNESS WHEREOF we have caused these Our Letters to be made Patent.

The Department of the Environment has made a Statutory Rule entitled **The Community Drivers' Hours (Foot-and-Mouth Disease) (Temporary Exception)(No. 2) (Amendment No. 6) Regulations (Northern Ireland) 2001 (S.R. 2001 No. 398).**

These Regulations, which came into operation on 4th November, 2001 and extend to 29th December, 2001 (inclusive) extend the relaxation of the EU drivers' hours rules with the removal of the temporary exception of the weekly rest requirement, except for vehicles being driven for the purpose of the movement of livestock, in order to meet the exceptional circumstances occasioned by the outbreak of foot-and-mouth disease in Northern Ireland.

THE PLANNING (NORTHERN IRELAND) ORDER 1991

The Belfast Metropolitan Area Plan 2015 is a Development Plan being prepared under the provisions of Part III of the Planning (Northern Ireland) Order 1991 by the Planning Service, an Agency within the Department of the Environment. It relates to the administrative areas of Belfast, Carrickfergus, Castlereagh, Lisburn, Newtownabbey and North Down Councils. The Plan, which will be prepared within the context of the Regional Development Strategy, will inform the general public, statutory authorities, developers and other interested bodies of the policy framework and land use proposals that will be used to guide development decisions within the six Council Areas up to the year 2015. The Department published on Friday 7th December, the "Belfast Metropolitan Area Plan 2015 - Issues Paper" for the purposes of public consultation and participation. In order to promote an inclusive consultation process a number of public meetings will be held throughout the Plan area, details of which will shortly be advertised in the local and regional press.

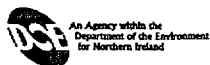

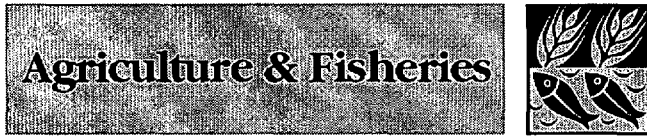
The Department has received the following planning application, accompanied by an Environmental Statement, for development which is likely to have significant effects on the environment in the Republic of Ireland –

Application No: L/200111346/F

Location: Garrane, Mullaghfad, Corraleek, and Corragunt, Rosslea

Proposal: A wind farm comprising up to 10 turbines (each turbine has a maximum overall height of 100m) and associated transformers, one permanent anemometer mast, access tracks and gates, a site control room and substation, electrical cabling, a temporary site compound and all ancillary works.
