WHEREAS by Orders made by me on the 5th day of August, 1922, the circulation in Northern Ireland of the papers entitled "The Freeman's Journal" and "The Evening Telegraph," a paper published in Dublin, was prohibited until the 5th day of September, 1922, and Whereas certain copies of each of the said papers which were being circulated by the Great Northern Railway Company of Ireland after the said Orders were made, have been seized at Bessbrook Railway Station in Northern Ireland.

NOW I, the Right Honourable Sir Richard Dawson Bates, Minister of Home Affairs for Northern Ireland, in exercise of the powers vested in me as Civil Authority by the Civil Authorities (Special Powers) Act, (Northern Ireland), 1922, and of all other powers enabling me in this bahalf, do hereby Order that the said copies so seized shall be destroyed.

READY-MADE AND WHOLESALE BE-SPOKE TAILORING TRADE BOARD (NORTHERN IRELAND).

The Trade Board established under the powers vested in the Ministry of Labour for Northern Ireland, and in pursuance of Section 8 of the Government of Ireland Act, 1920, and
