FACTORY AND WORKSHOP ACT, 1901.

NOTICE is hereby given in pursuance of Section 80 of the Factory and Workshop Act, 1901, that the Ministry of Labour for Northern Ireland has amended the Draft Regulations for manufactures and processes incidental thereto carried on in Chemical Works which were issued by the Home Office, London, on 24th December, 1920, and proposes to make Regulations in accordance with the amended draft issued on 4th October, 1922. Copies of the revised draft Regulations (which follow the Regulations made by the Home Office, London, on 11th July, 1922) may be obtained on application to the Ministry of Labour, 7 Upper Queen Street, Belfast. Any objections with respect to the revised Draft Regulations by or on behalf of any person affected thereby must be sent to the Secretary, Ministry of Labour, within twenty-one days after the date of notice. Every such objection must be in writing, and must state:—

- (a) The Draft Regulations or portions of the Draft Regulations objected to,
- (b) the specific grounds of objection, and
- (c) the omissions, additions and modifications asked for.

ORDER OF THE CHIEF SECRETARY FOR IKELAND, DATED 29/9/22.

THE IMPORTATION OF SHEEP FROM SCOTLAND (NORTHERN IRELAND) ORDER, 1922.

I, The Right Honourable Sir Hamar Greenwood, Bart, K.C., M.P., Chief Secretary for Ireland, by virtue and in exercise of the powers vested in me under the Provisional Government (Council of Ireland) Order, 1922, and of every other power enabling me in that behalf, hereby Order as follows:—

REVOCATION.

1. The Importation (Sheep from Scotland) Order of 1916 (No. 3) Suspension Order of 1922, dated the 25th January, 1922, is hereby revoked as regards Northern Ireland Ports as from the 2nd October, 1922.

2. So long as this present Order remains in force the landing of sheep at Northern Ireland Ports shall be subject to the conditions prescribed by the Importation (Sheep from Scotland) Order of 1916 (No. 3), dated 29th December, 1916.

SHORT TITLE.

3. This Order may be cited as the Importation of Sheep from Scotland (Northern Ireland) Order, 1922.
