EMPLOYMENT RELATIONS (NORTHERN IRELAND) ORDER 2004 (S.I. 2004 No. 3078 (N.I. 19)).

It also clarifies the role of the companion at disciplinary and grievance hearings, and provides specific redress for employers who are dismissed or suffer other detriment because they have been summoned to jury service.

M2 Motorway Improvements

(Junctions 4 to 2) in the Townlands of Ballywonard & Ballybought, **Barony of Belfast Lower, County Antrim**

The Department for Regional Development having considered the matters set out in Article 67A(7) of the Roads (Northern Ireland) Order 1993 hereby gives notice in accordance with the provisions of Article 67A(8) and (9) of its intention to proceed with the proposed M2 Motorway Improvements, Junctions 4 to 2.

The general effect of the scheme will be to reduce congestion on the M2 Motorway between Sandyknowes (Junction 4) and Greencastle Interchange (Junction 2). The Belfast-bound carriageway of the M2 Motorway will be widened to provide three lanes between Sandyknowes roundabout and Greencastle Interchange. The country-bound carriageway will be widened through the Greencastle Interchange to provide three lanes and the existing Hightown, Collin and Longlands bridges over the M2 will be replaced.

Don't Freeze up this Winter

Take Action Now

How to prevent frozen and burst pipes:-

- Open the trap door into the roof space to allow hot air from the main house to enter.
- Open the doors to the sink unit to allow warmer air to circulate around the pipes.
- If your house will be unoccupied during a cold spell ask a friend or neighbour to run the heating for a short time and check for frozen pipes.
- Insulate pipe work in roof spaces and other exposed places.

In the event of pipes freezing:-

- Put hot water bottles or a thick cloth soaked in hot water over the frozen pipe. When thawing, start at the end of the pipe nearest the tap and work away from it.
- Never use a naked flame.

In the event of pipes bursting:-

- Turn off the main stopcock. This is normally under the kitchen sink, but may be elsewhere in the kitchen, bathroom, hall or garage.
- If the flow of water cannot be stopped, open all the cold taps to drain the system.
- If the burst is on a pipe from the storage tank, turn off the stop valve in the storage tank, turn on all hot taps to drain the system, allow the fire to burn out or turn the heating off until the burst pipe has been attended to by a plumber.
- Do not turn on the water supply until the burst has been repaired.
- If the water has come into contact with electrical fittings the electricity should be turned off at the mains.
