BY THE GOVERNOR OF NORTHERN IRELAND

ABERCORN.

WHEREAS it is provided by Section 13 of the County Officers and Courts Act (Northern Ireland), 1925, (hereinafter called "the Act") that the Governor of Northern Ireland shall have power to make regulations, upon the recommendation of the Minister of Home Affairs for Northern Ireland and of the Minister of Finance for Northern Ireland, for prescribing amongst other things, the conditions governing the promotion of persons employed in the county court service, and any other matter required to be prescribed for the purpose of giving full effect to the Act:

And whereas it is also provided by the said section that any such regulations, in so far as they are intended to apply to persons admitted under the provisions of Part II. of the Act to employment in the county court service, shall have effect only with the concurrence of the Lord Chief Justice of Northern Ireland:

Now, therefore, I, James Albert Edward, Duke of Abercorn, Governor of Northern Ire-

land, in pursuance of the said section, hereby make the following Regulation upon the recommendation of the Minister of Home Affairs for Northern Ireland and of the Minister of Finance for Northern Ireland, and with the concurrence of the Lord Chief Justice of Northern Ireland.

TRANSFERS AND PROMOTIONS.

Transfers or promotions in the County Court Service of persons admitted under the provisions of Part II. of the Act to employment in the County Court Service, shall be made on the direction of \cdot the Minister of Home Affairs, who shall have due regard to the claims and qualifications of the officers in the service and to the recommendations of the Clerk or Clerks of the Crown and Peace concerned.

TRADE BOARDS ACT (NORTHERN IRELAND), 1923. TOBACCO TRADE BOARD (NORTHERN IRELAND).

WHEREAS the Ministry of Home Affairs for Northern Ireland has one month previous to the date of this Order received an application signed by twenty-one or more local government electors registered in respect of qualifications in the area comprised within the boundaries hereinafter specified (which area is herein referred to as "the town of Kilkeel") in the administrative County of Down, applying that the provisions of the Towns Improvement (Ireland) Act, 1854, may be carried into execution in the town of Kilkeel, and specifying the boundaries proposed for the purposes of the said Act:

And whereas the said application has been duly published in the manner by the said Act directed :

And whereas the town of Kilkeel is a town within the meaning of Section 1 of the Towns Improvement (Ireland) Act, 1854:

Now therefore the Ministry of Home Affairs for Northern Ireland hereby signifies its approval of the proposed boundaries as hereinafter described and specified, namely the boundaries delineated in red on the Ordnance Map annexed to the said application and Sealed in duplicate with the Seal of the Ministry of Home Affairs this sixteenth day of April, 1934 (which said Map is hereinafter referred to as the "Ordnance Map"), and comprising the townlands of Kilkeel and Magheramurphy, in the Rural District of Kilkeel and County of Down, delineated on the Ordnance Map as aforesaid, that is to say:—

Commencing at the intersection of High Water Mark with the Townland Boundary between Derryogue and Magheramurphy marked "A," thence along the same Townland Boundary in a North-Westerly direction to a point marked "B," and continuing along the Townland Boundary between Dunnaman and Magheramurphy from the said point marked "B" to the centre of Aughrim River at the Ford marked "C," thence along the Townland Boundary in centre of Aughrim River between the townlands of Magheramurphy and Drumcro to a point marked "D," thence in a Northerly direction along the Boundary between the townlands of Drumcro and Kilkeel, to a point marked "E," continuing in an Easterly direction along the Townland Boundary between the townlands of Kilkeel and Aughnaloopy to a point marked "F," thence in a South-Easterly direction along the centre of stream on the Boundary between the townlands of Kilkeel and Aughnahoory to a point in the centre of Kilkeel River marked "G," and continuing North-East along the Boundary between the townlands of Aughnahoory and Kilkeel to a point marked "H." From thence in a direction along the Townland Southerly Boundary between the townlands of Kilkeel and Magheragh to intersection with High Water Mark at point marked "J," thence continuing in a South-Westerly direction along High Water Mark to its commencement at the point marked "A.

Provided always that, if there be any discrepancy between the boundaries hereinbefore described and the boundaries delineated on the Ordnance Map, the Ordnance Map shall prevail :

And the Ministry hereby directs you, James Linton, of Pookey Green, Aughnahorry, Kilkeel, County Down, and John Moore Orr, of Greencastle, Ballyardle P.O., Newry, County Down, being Justices of the Peace resident within 10 miles of the town of Kilkeel, to convene a Meeting for the purpose of considering the carrying of the provisions of the Towns Improvement (Ireland) Act, 1854, into execution within the said boundaries, and that one of you do preside at such Meeting.

- B. (a) Planed and tongued and grooved or planed and otherwise manufactured hardwood flooring blocks or strips;
 - (b) Hardwood parquet flooring in sections composed of blocks or strips glued or otherwise joined together.

Attention is called to the fact that, while, under the provisions of the above Act, the Committee must in every case referred to them consider whether the goods should bear an indication of origin at the time of sale or exposure for sale, they may also at their discretion consider and report upon the question whether such goods should bear an indication of origin at the time of importation.
