MINUTE DETERMINING THE CONDITIONS UPON WHICH GOVERNMENT LOANS MAY BE REDEEMED BEFORE THEIR DUE DATES OF REPAYMENT.

Pursuant to section 2 (2) of the Exchequer and Financial Provisions Act (N.I.), 1926, the Ministry of Finance hereby determines that, in order to protect the Government Loans Fund from losses in respect of the redemption of Ulster Loan Stock, the redemption of Loans issued from the Government Loans Fund in advance of the date or dates at which, in accordance with the terms agreed to by the borrower at the time when the loan was made, the principal of such loans falls due for payment, shall be effected by the transfer to the Ministry:

(a) of an amount of Ulster Loans Stock calculated as follows:—

For every £100 principal of loans to be redeemed, either 4½% Ulster Loans Stock, 1945-75, to the amount of £109 12s. 11d., or 5% Ulster Loans Stock, 1950-60, to the amount of £102 6s. 7d.

(b) (In special cases) of such amount of cash for every £100 principal of loans to be redeemed as the Ministry may from time to time determine having regard to the market price of the Stock aforesaid and its availability for purchase and cancellation by the Ministry.

Provided always that the Ministry may accept (subject to due notice being received) repayment at any time on the basis of £100 cash for each £100 cash advanced in the following cases, namely,

- (1) Unexpended balance of loans already advanced, when the Ministry is satisfied that the balance is unexpended either because the scheme, in respect of which the loan was issued, is less costly than was anticipated, or because it has been definitely reduced in extent.
- (2) Loans issued to local authorities for the purpose of making advances under the Small Dwellings Acquisition Acts when, and to the extent that, repayment is effected by the proprietor of a house under the provisions of sub-section (5) of section one of the Small Dwellings Acquisition Acts (N.I.), 1899 to 1925.
- (3) Loans of £1,000 or less issued to individuals and subject to repayment over a period of not more than twenty years or issued under the Glebe Loans (Ireland) Acts.

And whereas by Article 6 of the said Order it is (amongst other things) provided that the said Order shall come into force so far as regards goods specified in Class III. of the Schedule thereof on the 1st

March, 1935:

And whereas the Board of Trade, being the appropriate Department in this case, having considered representations made to them in that behalf by persons appearing to the Board to have a substantial interest in the matter, are satisfied that the application of the aforesaid provisions of Article I of the said Order to sacks and bags of the aforesaid descriptions prior to the first day of April, 1935, is likely to cause hardship to the said persons:

Now, therefore, the Board of Trade, in pursuance of the powers conferred upon them by the said Section 3, hereby direct

as follows:—

- 1. Until the first day of April, 1935, Article I of the Merchandise Marks (Imported Goods) No. 10 Order, 1934, shall not apply to imported sacks and bags made wholly or mainly of woven piece goods wholly or partly of jute, whether or not coated, impregnated or in any other way treated or operated upon.
- 2. This Direction may be cited as the Merchandise Marks (Imported Goods) Exemption Direction (No. 5), 1934.
