The King has been pleased, by Royal Warrant bearing date the 21st ultimo, to re-appoint His Grace the Duke of Abercorn, K.G., K.P., to be Governor of Northern Ireland for a period of six years as from the 9th December, 1934.

WHEREAS it is enacted by Section 6 of the Petty Sessions Clerk (Ireland) Act, 1858, that it shall be lawful for the Lord Lieutenant to Order and declare that from a certain time therein to be named two or more districts shall be served by one and the same person as Clerk:

And whereas by the Government of Ireland Act, 1920, the Orders made thereunder and the Irish Free State (Consequential Provisions) Act, 1922, the powers of the Lord Lieutenant in this respect became vested in and are now exercisable by the Governor of Northern Ireland:

And whereas by the Petty Sessions Fees and Administration Act (Northern Ireland), 1923, it is provided that the power of the Governor of Northern Ireland to make an Order declaring that two or more Petty Sessions Districts shall be served by one and the same person as Clerk shall be exercisable in respect of any districts whether they are all situate in the same county or not, and it is thereby further provided that

the appointment of a person to be the Clerk of such two or more Districts shall, on the first occasion for such appointment, in pursuance of the Order, be made by the Governor of Northern Ireland, who shall select for appointment some one of the persons who filled the office of Petty Sessions Clerk in any of those districts immediately before the coming into force of the Order, or, in the case of the unfitness of all such persons, then some other proper and fit person, and that the salary to be paid to the Clerk so appointed on the first occasion aforesaid for two or more districts shall notwithstanding anything in Section 6 of the Petty Sessions Clerk (Ireland) Act, 1858, be such as the Governor of Northern Ireland in his discretion may fix:

Now, I, James Albert Edward, Duke of Abercorn, K.G., K.P., Governor of Northern Ireland, in pursuance of the powers conferred upon me by the above-mentioned Acts and all other powers me thereunto enabling, do hereby Order and Declare that the Petty Sessions Districts of Castlewellan, Kilkeel, Newcastle and Seaforde, in the County of Down, shall from the 28th day of November, 1934, be served by one and the same person as Clerk:

And I do further appoint Francis Robert Russell, at present Clerk of the Petty Sessions for the District of Kilkeel, to be Clerk of the Districts of Castlewellan, Kilkeel, Newcastle and Seaforde:

And I do further direct that the Clerk of Petty Sessions of the Districts of Castlewellan, Kilkeel, Newcastle and Seaforde shall reside within a distance of one and a half miles of the place in which the Court House for the Petty Sessions District of Newcastle is situate:

And I do further fix the salary of the said Francis Robert Russell as Clerk of the aforesaid Districts of Castlewellan, Kilkeel, Newcastle and Seaforde at the annual sum of Two Hundred and Seventy-five Pounds.

HOUSING-NORTHERN IRELAND. COUNTY BOROUGH OF LONDONDERRY.

1. As from the date of this Order the rate of interest on advances made under Section 1 of the Small Dwellings Acquisition Act, 1899, by the Council of the County Borough of Londonderry shall, notwithstanding anything contained in the Rates of Interest (Housing) Order, Northern Ireland, 1934, be four and one-half per cent. per annum.

Provided that nothing in this Order shall affect the rate of interest on any advances made or to be made in respect of contracts entered into or applica-tions granted under the said Section prior to the date of this Order.

2. This Order may be cited as the County Borough of Londonderry (Rate of Interest) Order, 1934.

MILK AND MILK PRODUCTS ACT (NORTHERN IRELAND), 1934.

DETERMINATION OF JOINT MILK COUNCIL FOR NORTHERN IRELAND.

The Joint Milk Council for Northern Ireland, in the exercise of its powers under Section Six of the Milk and Milk Products Act (Northern Ireland), 1934, hereby determines as follows:-

PRODUCER'S PRICES.

On and after the 16th day of December, 1934, until the 12th day of May, 1935, Milk of Grade A, Grade B and Grade C shall be sold by the holder of a Producer's licence to the holder of a Distributor's licence at the following prices:-

For milk sold loose:

Milk of Grade A, not less than 1/4½ per gallon.

Milk of Grade B 1/2½d. per gallon.

Milk of Grade C

For milk bottled on the farm:

11d. per gallon above price for the appropriate grade of milk sold loose,

bottles and caps being supplied by the distributor.

The above prices represent the prices for milk delivered at the premises of a holder of a Distributor's licence, and are subject to a deduction in respect of carriage when this service is performed by the holder of a Distributor's licence to whom the milk has been sold. For milk delivered within the County Borough of Belfast, the maximum deduction in respect of carriage which may be made from the above prices is as follows:

Another 1d. may be deducted from the prescribed price in respect of every 10 miles or part thereof above 35 miles at which the premises of the holder of a Producer's licence from which milk is collected are situated from the centre of Belfast.

SALE BY CONTRACT.

On and after the 30th day of December, 1934, all milk sold by the holder of a Producer's licence to the holder of a Distributor's licence shall be sold under contract. terms on which contracts shall be made for the sale of milk of Grade A, Grade B or Grade C by holders of Producers' licences to holders of Distributors' licences shall be in accordance with those specified in the first part of this document. All contracts for the sale of milk by holders of Producers' licences to holders of Distributors' licences shall be in the form set forth in the schedule hereto, and shall be registered by the Council.

- (1) Subject to the provisions of Section Seven of the Milk and Milk Products Act (Northern Ireland), 1934, the Council may refuse to register a contract which is not in accordance with the aforesaid terms or in the prescribed form:
- 2) The Council may refuse to register a contract if one of the parties thereto has previously been a party to a contract registered with the Council which has been determined b yreason of the non-fulfilment by that party of the terms of the said registered contract.

RETAIL PRICES.

On and after the 16th day of December, 1934, until the 12th day of May, 1935, milk of Grade A, Grade B and Grade C sold by retail and delivered to the purchaser shall be sold at the following prices :-

Milk of Grade A—Not less than 2/2 per gallon. Milk of Grade B—2/- per gallon. Milk of Grade C—1/10 per gallon.

Provided that

- (a) A daily sale of milk exceeding one gallon may be sold at not more than 4d. per gallon less than the above prices.

The purchaser shall take all reasonable steps to overcome the risk of infection and to accept full supply as soon as possible.

The benefit and obligations of this Contract may with the previous consent in writing of the other party to this contract and of the Council be assigned by the Vendor to another registered producer or by the Purchaser to a third party, and it is hereby expressly agreed and declared that every such assignment duly assented to as aforesaid shall be deemed to have relieved the assignor of his obligation to deliver or take milk under this Contract after the date of the said assignment.
