### CIVIL AUTHORITIES (SPECIAL POWERS) ACT (NORTHERN IRELAND), 1922.

WHEREAS by section 26 of the Regulations contained in the Schedule to the Civil Authorities (Special Powers) Act (Northern Ireland), 1922, it is provided that the Civil Authority may by notice prohibit the circulation of any newspaper for any specified period and that the person circulating or distributing such newspaper within such specified period shall be guilty of an offence against the Regulations in the said Schedule:

Now, I, the Right Honourable Sir Richard Dawson Bates, Minister of Home Affairs for Northern Ireland, being the Civil Authority under the said Act, do hereby prohibit the circulation of the following Newspapers entitled:—

- “An Phoblacht” or “The Republic” or “The Loyalist” or “The Republican Press,”
- “The Irish World and American Industrial Liberator,”
- “Irish Freedom” or “Saoirse na h'Eireann,”
- “Fianna,” and
- “Republican Congress,”

or under any other title or alias whatever in Northern Ireland, from the 1st day of

January, 1935, until the 31st day of December, 1935.

Of subjects 5 to 10, candidates may take two or three (not including more than one language) sufficient to give a maximum of 300 marks.

Admission to this Part of the competition will be restricted to those candidates (up to such number as may be determined by the Commissioners) who obtain the highest aggregate marks in Part I.

5. Subject to compliance with the provisions of paragraphs 1, 2 and 3, candidates will be offered vacant appointments in the order in which they are finally placed in regard to their aggregate marks in Parts I and II. of the competition. No candidate will be eligible for appointment who does not exhibit a reasonable standard of proficiency.
