THE SEEDS (MISCELLANEOUS AMENDMENTS) REGULATIONS (NORTHERN IRELAND) 2013

The Department of Agriculture and Rural Development has made a Statutory Rule entitled "The Seeds (Miscellaneous Amendments) Regulations (Northern Ireland) 2013", (S.R. 2013 No. 304), which comes into operation on 20th January 2014.

This Rule will transpose Directives 2012/37/EU and 2013/45/EU into domestic law. The transposition of these Directives is an EU obligation.

Directive 2012/37/EU provides for the Department to authorise an increase in the maximum weight of a seed lot for certain fodder grass species, and Directive 2013/45/EU changes the botanical name of the tomato
