I, The Right Honourable Sir Richard Dawson Bates, Minister of Home Affairs for Northern Ireland, in pursuance of the powers vested in me by Section 5 of the Road and Railway Transport Act (Northern Ireland), 1935, and of all other powers in that behalf enabling me, but without prejudice to any further exercise of such powers, hereby order and direct that the period within which the Northern Ireland Road Transport Board may

acquire every road motor undertaking operated for hire or reward in Northern Ireland, including the passenger and freight road transport services of any railway company operating in Northern Ireland, shall be extended to the 1st day of July, 1937.

PIER AT BALLYCASTLE IN THE
COUNTY OF ANTRIM.

Bye-Laws, Rules, Regulations made, and Penalties imposed in respect of Offences against same, on the 13th day of December, 1935, by the Ministry of Commerce for Northern Ireland, pursuant to and in conformity with the powers conferred by the Acts 9 & 10 Victoria, cap. 3; 16 & 17 Vic., cap. 136; 29 & 30 Vic., cap. 45, and vested in the said Ministry by the Acts 15 & 16 Geo. 5, cap. 3 (N.I.) and 16 Geo. 5, cap. 4 (N.I.), to be enforced by the Pier Constable appointed by the County Council of the County of Antrim, for the Pier of Ballycastle.

- I. Fishery Boats and Vessels of every description engaged in the Fisheries and Boats plying to or from Rathlin Island shall at all times be entitled to a reasonable preference of Berths and Moorings at the Pier as assigned by the Pier Constable, provided always that the said preference will not hinder or prevent one cargo boat at a

- time from using a deep water berth at the Pier, such rights to be interpreted by the Pier Constable, whose decision shall be final.
- II. No Boat or Vessel shall be made fast to coping stones or other parts of the Quays or Works of the Pier, nor have grapnels or stakes on the Quays, but all Boats and Vessels shall make fast to the Bollards, Rings or Moorings provided for that purpose.
 - III. No person shall discharge, throw or put into the berths at or adjoining the Pier or into the sea within the precincts of the Pier any ballast, stones, gravel, earth, sand, ashes or rubbish of any description.
 - IV. No person shall disturb, remove, or injure or cause to be disturbed, removed or injured, any Coping, Paving or other stones, or any Post Notice Board or Rings, or other parts of or matters belonging to the Pier Works, and no person shall dig or take away any ballast, shingle, stone or other material from within or around the Pier without the leave of the Pier Constable first being obtained.
 - V. No ballast, stones, sand, mud, manure, or other matter or thing landed or deposited on the Pier, or any part thereof, shall be allowed to remain longer than twenty-four hours thereon, or be placed within six feet of the edge of the Pier.
 - VI. No person shall deposit or leave cinders, road sweepings, ashes, or other rubbish, or fish refuse, offal, or any offensive matter likely to create a nuisance or be injurious to the public health, upon the Pier or the approaches thereto.
 - VII. Fish landed or exposed for sale must be removed from within the limits of the Pier on the day of landing, if practicable, and if not, before eight o'clock on the following morning, and no person shall open or clean any fish at any place within the limits of the Pier.
 - VIII. Except with the previous sanction of the Pier Constable, no Explosive or Commodity liable to spontaneous combustion, Petroleum, putrid fish, bones, or other dangerous or offensive articles or things, or anything injurious to health, or causing or likely to cause danger or a nuisance on the Pier shall be imported to, or exported from or brought or landed upon the Pier.
 - IX. All Yawls or small Boats which shall be hauled up, shall be placed in the respective Berths assigned to them by the Pier Constable, and no such Boats shall on any account be left on the Slip or Quays.
 - X. Every person in charge of any Boat, Ship, Lighter, or Barge, frequenting the Pier shall moor the same in such

place as shall be directed by the Pier Constable.

- XI. No person shall cut, injure, or destroy the mooring or fastening of any Boat or Vessel, or loosen or remove any Boat or Vessel from its moorings without the leave or authority of the owner thereof.
- XII. No person shall assault or obstruct the Pier Constable or any person employed by him, in the execution of his duty, or aid or incite others thereto.

Whereas it hath pleased Almighty God to call to His Mercy our late Sovereign Lord King George the Fifth, of Blessed and Glorious Memory, by whose Decease the Imperial Crown of Great Britain, Ireland and all other His late Majesty's Dominions is solely and rightfully come to the High and Mighty Prince Edward Albert Christian George Andrew Patrick David; We, therefore, the Lords Spiritual and Temporal of this Realm,

being here assisted with these of His late Majesty's Privy Council, with Numbers of other Principal Gentlemen of Quality, with the Lord Mayor, Aldermen, and Citizens of London, do now hereby with one Voice and Consent of Tongue and Heart, publish and proclaim, That the High and Mighty Prince Edward Albert Christian George Andrew Patrick David, is now, by the Death of our late Sovereign of happy Memory, become our only lawful and rightful Liege Lord Edward the Eighth, by the Grace of God, of Great Britain, Ireland and the British Dominions beyond the Seas, King, Defender of the Faith, Emperor of India; To whom we do acknowledge all Faith and constant Obedience, with all hearty and humble Affection; beseeching God, by whom Kings and Queens do reign, to bless the Royal Prince Edward the Eighth with long and happy Years to reign over us.

Given at St. James's Palace, this twenty-first day of January, in the year of our Lord One thousand nine hundred and thirty-six.
