His Majesty in Council was this day pleased to declare that having again been stricken by illness He was unable for the time being to give due attention to the affairs of the Realm, whereupon the Draft of a Commission making provision for the summoning and holding of the Privy Council and for the transaction of other matters and things on behalf of His Majesty, more particularly specified in the Schedule annexed thereto, was this day read at the Board and approved; and His Majesty was further pleased to nominate Her Majesty The Queen, His Royal Highness The Prince of Wales, K.G., K.T., K.P., G.C.S.I., G.M.M.G., G.C.I.E., G.C.V.O., G.M.B.E., His Royal Highness the Duke of York, K.G., K.T., G.C.M.G., G.C.V.O., and His Royal Highness The Duke of Gloucester, K.G., K.T., K.P., G.C.M.G., G.C.V.O., for the purposes therein mentioned and to declare that they should be designated under the style and title of Counsellors of State.

His Majesty was also pleased by and with the advice of His Privy Council to order, and it is hereby ordered, that the Right Honourable Sir John Simon, one of His Majesty's Principal Secretaries of State, do cause a Warrant to be prepared, for His Majesty's Royal Signature, for passing under the Great Seal of the Realm a Commission conformable to the said Draft which is hereunto annexed.

George the Fifth by the Grace of God, of Great Britain, Ireland and the British Dominions beyond the Seas King, Defender of the Faith, Emperor of India: To all to whom these Presents shall come, Greeting!

Whereas by Our Letters Patent under Our Great Seal dated the eighth day of June in the Twentieth year of Our Reign We did appoint certain Counsellors of State and did provide for the delegation of certain of Our functions to the said Counsellors in order that We pending the full restoration of our health and strength should be relieved of the burden of transacting certain matters and things more particularly specified in the Schedule annexed to Our said Letters Patent:

And whereas We have again been stricken by illness and are unable for the time being to give due attention to the affairs of Our Realm:

Now Know Ye that We do by these Presents revoke Our said Letters Patent of the eighth day of June one thousand nine hundred and twenty-nine; and Further Know Ye that We having entire confidence in the fidelity of Our Most dearly beloved Consort The Queen; Our Most dear and entirely beloved Son and Most faithful Counsellor Edward Albert Christian George Andrew Patrick David, Prince of Wales, Knight of Our Most Noble Order of the Garter, Knight of Our Most Ancient and Most Noble Order of the Thistle, Knight of Our Most Illustrious Order of Saint Patrick, Knight Grand Commander of Our Most Exalted Order of the Star of India, Grand Master and Principal Knight Grand Cross of Our Most Distinguished Order of Saint Michael and Saint George, Knight Grand Commander of Our Most Eminent Order of the Indian Empire, Knight Grand Cross of Our Royal Victorian Order, Grand Master and Principal Knight Grand Cross of Our Most Excellent Order of the British Empire; Our Most dear and entirely beloved Son and Most faithful Counsellor Albert Frederick Arthur George, Duke of York, Knight of Our Most Noble Order of the Garter, Knight of Our Most Ancient and Most Noble Order of the Thistle, Knight Grand Cross of Our Most Distinguished Order of Saint Michael and Saint George, Knight Grand Cross of Our Royal Victorian Order; Our Most dear and entirely beloved Son and Most faithful Counsellor Henry William Frederick Albert, Duke of Gloucester, Knight of Our Most Noble Order of the Garter, Knight of Our Most Ancient and Most Noble Order of the Thistle, Knight of Our Most Illustrious Order of Saint Patrick, Knight Grand Cross of Our Most Distinguished Order of Saint Michael and Saint George, Knight Grand Cross of Our Royal Victorian Order; and Our Most dear and entirely beloved Son George Edward Alexander Edmund, Duke of Kent, Knight of Our Most Noble Order of the Garter, Knight of Our Most Ancient and Most Noble Order of the Thistle, Knight Grand Cross of Our Most Distinguished Order of Saint Michael and Saint George, Knight Grand Cross of Our Royal Victorian Order; Of Our most especial grace certain knowledge and mere motion do nominate and appoint Our said Most dearly beloved Consort The Queen and Our said Most dearly and entirely beloved Sons The Prince of Wales, The Duke of York, The Duke of Gloucester and The Duke of Kent, to be Our Counsellors of State until the further signification of Our Pleasure and We do by these Presents give and grant unto Our said Counsellors of State or any two of them full power and authority from henceforth until the further signification of Our Pleasure to summon and hold on Our behalf Our Privy Council and to signify thereat Our approval of any matter or thing to which

Our approval in Council is required and to approve and sign on Our behalf any of the documents specified in the Schedule hereunto annexed and further to do on Our behalf any of the other matters and things specified in the said Schedule, and to do on Our behalf any matter or thing which appears to them necessary or expedient to do on Our behalf in the interests of the safety and good government of Our United Kingdom, India, Our Colonies and the Protectorates and Territories administered under Mandate by Our Government in the United Kingdom; save only that they Our said Counsellors of State, The Queen, The Prince of Wales, The Duke of York, The Duke of Gloucester and The Duke of Kent, shall not dissolve Parliament or in any manner grant any rank, title, or dignity of a Peerage or act in any manner or thing on which it is signified by Us or appears to them that Our special approval should be previously obtained; and We further direct that until the further signification of Our Royal Pleasure, These Presents shall take effect notwithstanding the death or incapacity of any of Our said Counsellors of State, The Queen, The Prince of Wales, The Duke of York, The Duke of Gloucester and The Duke of Kent, so long as two of those Counsellors of State remain capable of acting thereunder.

ROAD AND RAILWAY TRANSPORT ACT (NORTHERN IRELAND), 1935. SCHEME FOR POOLING RECEIPTS OF THE NORTHERN IRELAND ROAD TRANSPORT BOARD AND THE RAILWAY COMPANIES.

I, the Right Honourable Sir Richard Dawson Bates, Minister of Home Affairs for Northern Ireland, in pursuance of the powers vested in me by Section 14 of the Road and Railway Transport Act (Northern Ireland), 1935, (in this Order referred to as "the Act") and of all other powers in that behalf enabling me, but without prejudice to any further exercise of such powers, hereby order and direct that the period within which the Joint Committee established under the aforesaid Section, shall prepare and submit to the Northern Ireland Road Transport Board and to each of the railway companies mentioned in said section, the pooling scheme framed in accordance with the provisions of the First Schedule to the Act, shall be extended to the 15th day of July, 1936.

REGULATIONS RESPECTING AN OPEN COM-PETITION FOR THE SITUATION OF WRITING ASSISTANT (FEMALE) IN THE CIVIL SER-VICE OF NORTHERN IRELAND, COMMENCING 22nd APRIL, 1936.

- 1. A candidate must be 18 years of age or upwards and under 20 years of age on the 31st March, 1936.
- Every candidate must be a natural-born British subject, the child of a person who is or was at the time of death a British subject; provided that if the Civil Service Commissioners are satisfied in the case of any candidate who is a British subject, but does not fulfil all the requirements of the rule as to nationality and descent, that the candidate is so closely connected by ancestry and upbringing with His Majesty's Dominions that an exception may properly be made to that rule, they may accept such candidate as eligible provided that this discretion shall not be exercisable unless (a) the father or the paternal grandfather of the candidate was a natural-born British subject, and (b) neither the father nor the paternal grandfather had acquired any other nationality by naturalisation or by any other voluntary and formal act.
- 3. A candidate must be unmarried or a widow.
- 4. A person upon whose training for the occupation of teacher public money has been

spent, cannot, if successful, be appointed until the consent of the Ministry of Finance has been notified to the Civil Service Commissioners.
